Re: Delisting of Commodity Swaps and Related Rule Amendments - Submission Pursuant to Section 5c(c)(1) of the Act and Regulations and 40.6(a)

Dear Ms. Jurgens:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (the “CEA”) and the Commodity Futures Trading Commission (the “Commission”) Regulation 40.6(a), ICE Swap Trade, LLC (“IST” or “SEF”) hereby notifies the Commission that it has amended its Rulebook. The Rulebook has been amended to delist 59 energy contracts from trading on April 23, 2021 (based on an acknowledged filing date of April 19, 2021).

The removed definitions and delisted contract terms and conditions set forth in Chapter 13 of the ICE Swap Trade Rulebook (“Rules”) are specified in **Exhibit A**. A copy of the revised Rulebook marked to show changes against the Rulebook submitted to the Commission with an effective date of April 23, 2021, is attached as **Exhibit B**, and a clean copy of the revised Rulebook is attached as **Exhibit C**. The delisted contracts are confirmed to have no open interest as of the date of the filing.
