**RE: Notice of Emergency Action: Amend Expiration Date for Weekly China 50 Binary Contract - Submission Pursuant to Commission Regulation §40.6(a)**

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (the “Act”), and §40.6(a) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act, North American Derivatives Exchange, Inc. (“Nadex”) hereby submits to the Commission this notice of emergency action.

The Nadex Weekly China 50 Binary contracts, based on the underlying SGX FTSE Xinhua China A50 Index Futures, were listed on Monday, June 3, 2019 with an expiration date of Friday, June 7, 2019. Due to a China holiday on June 7, 2019, the underlying SGX FTSE Xinhua China A50 Index Futures will not be available on that day. Pursuant to the Nadex Product Schedule Guidelines for Holidays, in instances of an underlying market closing early, the Exchange will adjust its contracts to reflect this early close. Accordingly, Nadex is amending the expiration date of its Weekly China 50 Binary contracts to June 6, 2019, in order to coincide with the early close in the underlying market. No open interest existed in the Weekly China 50 Binary contract at the time of this change, and therefore no market participant will be negatively impacted.

No substantive opposing views were expressed to Nadex with respect to this emergency action.
