Dear Sir or Madam,

Pursuant to Section 5c(c) of the Commodity Exchange Act and Section 40.6(a) of the regulations of the Commodity Futures Trading Commission, KalshiEX LLC (Kalshi) hereby notifies the Commission that it is amending the "Will <storm name> be at least a <tropical storm/hurricane category number>?" contract (Contract). There is no open interest in the previous iteration of the contract, whose last iteration expired in autumn 2021. The Exchange intends to list the amended contract when a new storm gets named. The Contract's terms and conditions (Appendix A) includes the following strike conditions:

- <**storm name**> (name)
- <tropical storm/hurricane category number> (hurricane category number)
- <date> (target date)

This contract is a straightforward amendment of the previous HURCAT market. The changes are minor and as follows:

- Changing the Expiration Date from a fixed date to the standard variable expiration language to be consistent with other Kalshi contracts
- Changing the latest possible Last Trading Time from 9:00 PM to 10:00 AM (and making it variable) to be consistent with other Kalshi markets and to be consistent with other Kalshi contracts
- Changed name to be consistent with CFTC best practices

Along with this letter, Kalshi submitted the following documents:

- A clean copy of the amended Contract; and
- A redline showing the changes to Appendix A, the product rules and terms and conditions of the contract.

CONCISE EXPLANATION AND ANALYSIS OF THE PRODUCT AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION'S REGULATIONS THEREUNDER

Pursuant to Commission Rule 40.2(a)(3)(v), the following is a concise explanation and analysis of the product and its compliance with the Act, including the relevant Core Principles, and the Commission's regulations thereunder.

I. Introduction

The "Will <storm name> be at least a <tropical storm/hurricane category number>?" Contract is a contract relating to the strength of various Atlantic storms. After careful analysis, Kalshi (hereafter referred to as "Exchange") has determined that the Contract complies with its vetting framework, which has been reviewed by the CFTC and formed part of the Exchange's application for designation as a Contract Market ("DCM") that was approved by the Commission.

In the last five years, Atlantic hurricanes have inflicted over \$393 billion worth of damage in the United States. Tropical storms and hurricanes can disrupt essential services and utilities like hospitals, water lines, and electricity, displace individuals, destroy homes, and lower property values of affected areas. Climate change may, scientists report, both increase the frequency of tropical cyclones and increase their severity. "Since 1975," a 2013 study concludes, "there has been a substantial and observable regional and global increase in the proportion of Cat[egory] 4-5 hurricanes of 25-30 percent per °C of anthropogenic (human-caused) global warming." Naturally, the larger the size of the hurricane, the larger the economic impact. The Contract allows affected individuals, businesses, and other investors to hedge the risk that a hurricane or tropical storm poses to their livelihood.

Further information about the Contract, including an analysis of its risk mitigation and price basing utility, as well as additional considerations related to the Contract, is included in Confidential Appendices B, C, and D.

Pursuant to Section 5c(c) of the Act and CFTC Regulations 40.2(a), the Exchange hereby certifies that the listing of the Contract complies with the Act and Commission regulations under the Act.

General Contract Terms and Conditions: The Contract operates similar to other binary contracts that the Exchange lists for trading. The minimum price fluctuation is \$0.01 (one cent). Price bands will apply so that Contracts may only be listed at values of at least \$0.01 and at most \$0.99. Further, the Contract is sized with a one-dollar notional value and has a minimum price fluctuation of \$0.01 to enable Members to match the size of the contracts purchased to their economic risks. The Exchange has further imposed position limits (defined as maximum loss exposure) of \$25,000 USD on the Contract. As outlined in Rule 5.12 of the Rulebook, trading shall be available at all times outside of any maintenance windows, which will be announced in advance by the Exchange. Members will be charged fees in accordance with Rule 3.6 of the Rulebook. Fees are charged in such amounts as may be revised from time to time to be reflected on the Exchange's Website. Additionally, as outlined in Rule 7.2 of the Rulebook, if any event or any circumstance which may have a material impact on the reliability or transparency of a Contract's Source Agency or the Underlying related to the Contract arises, Kalshi retains the authority to designate a new Source Agency and Underlying for that Contract and to change any associated Contract specifications after the first day of trading. That new Source Agency and Underlying would be objective and verifiable. Kalshi would announce any such decision on its website. All instructions on how to access the Underlying are non-binding and are provided for convenience only and are not part of the binding Terms and Conditions of the Contract. They may be clarified at any time. Furthermore, the Contract's payout structure is characterized by the payment of an absolute amount to the holder of one side of the option and no payment to the counterparty. During the time that trading on the Contract is open, Members are able to adjust their positions and trade freely. After trading on the Contract has closed, the Expiration Value and Market Outcome are determined. The market is then settled by the Exchange, and the long position holders and short position holders are paid according to the Market Outcome. In this case, "long position holders" refers to Members who purchased the "Yes" side of the Contract and "short position holders" refers to Members who purchased the "No" side of the Contract. If the Market Outcome is "Yes," meaning that storm <storm name> has reached <tropical storm/hurricane category number>, then the long position holders are paid an absolute amount proportional to the size of their position and the short position holders receive no payment. If the Market Outcome is "No," then the short position holders are paid an absolute amount proportional

to the size of their position and the long position holders receive no payment. Specification of the circumstances that would trigger a Market Outcome of "Yes" are included below in the section titled "Payout Criterion" in Appendix A.

TERMS OF CONTRACTS TRADED ON KALSHI

Official Product Name: Will <storm name> be at least <hurricane category number>? Rulebook: HURCAT

HURCAT

Scope: These rules shall apply to this Contract

Underlying: The set containing the maximum sustained wind-speeds of storm <storm name> from the National Oceanic and Atmospheric Administration's National Hurricane Center between Issuance and <date>.

Instructions: The information is available at

https://www.nhc.noaa.gov/archive/YYYY/XXXXX.shtml? where YYYY is the year of the storm and XXXXX denotes the name of the storm. For example,

To find the elements of the set, navigate to the link above and go to the column entitled "Discussion". Click on each of the hyperlinks. In each, navigate to the row (about 2/3rds down) that says INIT. In each, the maximum sustained wind-speed which is included in the set is the number preceding the word MPH. These instructions on how to access the Underlying are provided for convenience only and are not part of the binding Terms and Conditions of the Contract. They may be clarified at any time.

Source Agency: The Source Agency is the National Oceanic and Atmospheric Administration's ("NOAA") National Hurricane Center.

Type: The type of Contract is a Binary Contract.

Issuance: After the initial Contract, Contract iterations will be listed on an as-needed basis at the discretion of the Exchange and corresponding to the risk management needs of Members.

<tropical storm/hurricane category number>: Kalshi may list HURCAT contracts with <tropical storm/hurricane category number> levels of either <hurricane category number> from 1 through 5 or <tropical storm>. For example, <tropical storm/hurricane category number> could take the value "Hurricane Category Two", or "tropical storm".

<name>: <name> refers to a name specified by Kalshi. Kalshi may list iterations of the Contract corresponding to different variations of <name> from the list of NOAA Atlantic Tropical Storm names found here: https://www.nhc.noaa.gov/aboutnames.shtml.

<date>: <date> refers to a calendar date specified by Kalshi. Kalshi may list iterations of the Contract corresponding to different statistical periods of <date>.

Payout Criterion: The Payout Criterion for the Contract encompasses Expiration Values that are greater than or equal to the threshold for <tropical storm/hurricane category number>.

- The threshold for Category 1 is sustained wind speeds of at least 74 miles per hour
- The threshold for Category 2 is sustained wind speeds of at least 96 miles per hour
- The threshold for Category 3 is sustained wind speeds of at least 111 miles per hour
- The threshold for Category 4 is sustained wind speeds of at least 130 miles per hour
- The threshold for Category 5 is sustained wind speeds of at least 157 miles per hour

If the target is <tropical storm> the threshold is sustained wind speeds of at least 39 miles per hour.

Minimum Tick: The Minimum Tick size for the referred Contract shall be \$0.01.

Position Limit: The Position Limit for the \$1 referred Contract shall be \$25,000 per Member.

Last Trading Date: The Last Trading Date for the Contract will the sooner of the date of the first 10:00 AM ET following the occurrence of an event that is encompassed in the Payout Criterion (whereupon the Last Trading Time shall be 10:00 AM ET) or <date> (whereupon the Last Trading Time shall be 11:59 PM ET).

Settlement Date: The Settlement Date of the Contract shall be no later than the day after the Expiration Date, unless the Market Outcome is under review pursuant to Rule 7.1.

Expiration Date: The Expiration Date of the Contract shall be the date of the first 10:00 AM following the occurrence of an event that is encompassed in the Payout Criterion, or the day after <date>.

Expiration time: The Expiration time of the Contract shall be 10:00 AM ET.

Settlement Value: The Settlement Value for this Contract is \$1.00.

Expiration Value: The Expiration Value is the value of the Underlying as documented by the Source Agency on the Expiration Date at the Expiration Time.

Contingencies: Before Settlement, Kalshi may, at its sole discretion, initiate the Market Outcome Review Process pursuant to Rule 6.3(c) of the Rulebook. Additionally, as outlined in Rule 7.2 of the Rulebook, if any event or any circumstance which may have a material impact on the reliability or transparency of a Contract's Source Agency or the Underlying related to the Contract arises, Kalshi retains the authority to designate a new Source Agency and Underlying for that Contract and to change any associated Contract specifications after the first day of trading.

Scope: These rules shall apply to thise HURCAT Contract

Underlying: A set containing the maximum sustained wind-speeds of <u>storm</u> name> from the National Oceanic and Atmospheric Administration's National Hurricane Center.

In each, navigate to the row (about 2/3rds down) that says INIT. In each, the maximum sustained wind-speed which is included in the set is the number preceding the word MPH. <tropical storm/hurricane category number>: Kalshi may list HURCAT contracts with <tropical storm/hurricane category number> levels of either <hurricane category number> from 1 through 5 or <tropical storm>. For example, <tropical storm/hurricane category number> could take the value "Hurricane Category Two", or "tropical storm".

<name>: <name> refers to a name specified by Kalshi. Kalshi may list iterations of the Contract corresponding to different variations of <name> from the list of NOAA Atlantic Tropical Storm names found here: https://www.nhc.noaa.gov/aboutnames.shtml .

<date> refers to a calendar date specified by Kalshi. Kalshi may list iterations of the Contract corresponding to different statistical periods of <date>.

Payout Criterion: The Payout Criterion for the Contract encompasses Expiration Values that are greater than or equal to the threshold for <tropical storm/hurricane category number>.

If the target is <hurricane category number>, the thresholds are determined using the Saffir-Simpson Hurricane Scale as available on the National Weather Service's (NWS) website here: https://www.weather.gov/mfl/saffirsimpson.

- The threshold for Category 1 is sustained wind speeds of at least 74 miles per hour
- The threshold for Category 2 is sustained wind speeds of at least 96 miles per hour
- The threshold for Category 3 is sustained wind speeds of at least 111 miles per hour
- The threshold for Category 4 is sustained wind speeds of at least 130 miles per hour
- The threshold for Category 5 is sustained wind speeds of at least 157 miles per hour

If the target is <tropical storm> the threshold is sustained wind speeds of at least 39 miles per hour.

Minimum Tick: The Minimum Tick size for the referred Contract shall be \$0.01.

Position Limit: The Position Limit for the \$1 referred Contract shall be \$25,000 per Member.

Last Trading Date: <u>T</u>Unless otherwise noted by the Exchange and indicated on the Exchange website, the Last Trading Date for the Contract will the sooner of the date of the first 10:00 AM ET following the occurrence of an event that is encompassed in the Payout Criterion (whereupon the Last Trading Time shall be 10:00 AM ET), or <date> (whereupon the Last Trading Time for the Contract is 8:00pm ET on the Last Trading Date. No trading in the Contract shall occur after its Last Trading Date and Time.

Settlement Date: The Settlement Date of the Contract shall be <u>no later than</u> the day after the Expiration Date, unless the Market Outcome is under review pursuant to Rule 7.1.

Expiration Date: The Expiration Date of the Contract shall be the <u>date of the first 10:00 AM</u> following the occurrence of an event that is encompassed in the Payout Criterion, or the day after <date>. same day as the Last Trading Date.

Expiration time: The Expiration time of the Contract shall be 10:00 AM9:00pm ET.

Settlement Value: The Settlement Value for this Contract is \$1.00.

Expiration Value: The Expiration Value is the largest positive value of the Underlying as documented by the Source Agency on the Expiration Date at the Expiration Time.

Contingencies: Before Settlement, Kalshi may, at its sole discretion, initiate the Market Outcome Review Process pursuant to Rule 6.3(c) of the Rulebook. Additionally, as outlined in Rule 7.2 of the Rulebook, if any event or any circumstance which may have a material impact on the reliability or transparency of a Contract's Source Agency or the Underlying related to the Contract arises, Kalshi retains the authority to designate a new Source Agency and Underlying for that Contract and to change any associated Contract specifications after the first day of trading.
