Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended, and Commission Regulation 40.6(d), ICE Futures U.S., Inc. ("Exchange") submits notification to the Commission that, during the preceding week, the Exchange amended the terms and conditions for the Biofuel Outright Argus US B99 SME NYH Future ("BFD"), Biofuel Diff - Argus US B99 SME NYH vs Heating Oil 1st Line Future ("B9N"), and Biofuel Diff - Argus US B99 SME NYH vs NYH ULSHO 1st Line Future ("B99") to align the contract names and name of the reference price with the names of the assessments published by the relevant price reporting agency, Argus Media, by removing the "SME" text. The amendments are non-substantive in nature. All other aspects of the products' terms and conditions remain unchanged. Additionally, the Exchange made corresponding amendments to the Exchange Block Trade FAQ and Resolution Nos. 1 and 2 to Chapter 18 to reference the new naming convention for the products.
