Dear Mr. Kirkpatrick:

New York Mercantile Exchange, Inc. (“NYMEX” or “Exchange”) is certifying to the Commodity Futures Trading Commission (“CFTC” or “Commission”) amendments to the European Low Sulphur Gasoil (100mt) Bullet Futures contract (the “Contract”) effective Sunday, August 28, 2022 for trade date Monday, August 29, 2022 as follows:

- (1) CME Globex electronic trading (“CME Globex”) commodity code to **7F** to mirror the CME ClearPort code; and
- (2) daily settlement time of the Contract from 11:00 a.m. Central Time (CT) to **16:30 London Time** (collectively, the “Amendments”).

The Amendments shall streamline the commodity codes and better align the Contract in accordance with European trading hours.

The Exchange reviewed the designated contract market core principles (“Core Principles”) as set forth in the Commodity Exchange Act (“CEA” of the “Act”) and identified that the Amendments may have some bearing on the following Core Principles:

- **Availability of General Information:** The Exchange will publish on its website information regarding the Amendments via a Special Executive Report (“SER”) to notify the marketplace. The SER will also be posted on the CME Group website.
- **Daily Publication of Trading Information:** The Exchange will continue to publish the Contract’s trading volumes, open interest levels, and price information daily on its website and through quote vendors for the Contract.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the Amendments comply with the Act, including regulations under the Act. There were no substantive opposing views to the proposal.
