Pursuant to Commodity Futures Trading Commission (“CFTC” or “Commission”) Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of July 30, 2018.

Effective August 1, 2018, the Exchange was notified that Chicago & Illinois River Marketing LLC, a regular firm for delivery of Corn, Soybeans, Wheat, and Oats, changed its name to COFCO International Grains US LLC.
