Chicago Mercantile Exchange Inc. ("CME" or "Exchange") is certifying to the Commodity Futures Trading Commission ("CFTC" or "Commission") temporary amendments to the listing schedule of five (5) FX Weekly Option contracts to early list the Monday and Wednesday Week 1 and Friday Week 2 contracts (the "Contracts") listed in Appendix A below (collectively, the "Temporary Rule Amendments") effective Sunday, September 27, 2020 for trade date Monday, September 28, 2020. The Contracts are listed for trading on the CME trading floor¹ and the CME Globex electronic trading platform and for submission for clearing only on CME ClearPort.

Specifically, the Exchange will early list certain weekly contracts as noted in Appendix A effective for trade date September 28, 2020.

Pursuant to the Temporary Rule Amendments, the Exchange will list five weekly instead of four weekly contracts as shown in Appendix A.
