Pursuant to Commodity Futures Trading Commission ("CFTC" or "Commission") Regulation 40.6(d), the Exchange submits this weekly notification of the following amendments related to product terms and conditions made effective during the week of September 7, 2020.

Effective September 11, 2020, the Exchange was notified that CHS, Inc. changed its clearing agent to CHS Hedging, LLC for the firm's Corn, Soybean, Soybean Oil, and Ethanol transactions. The marketplace was alerted of the change via MKR #09-11-20, which is attached hereto as Exhibit A.
