Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and Section 40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) d/b/a crypto.com | Derivatives N.A., hereby provides notice that it amended the strike widths of various contracts during the week of September 12, 2022 due to increased or decreased volatility, as the case may be, in the underlying markets upon which the Nadex contracts are based. Amended strike widths are reflected in Exhibit A.
