To Whom It May Concern:

On this date, QCX LLC (“Polymarket US” or the “Exchange”) submitted via the CFTC Portal a product self-certification submission (the “Submission”) under 17 C.F.R. § 40.2. By this petition, the Exchange requests confidential treatment of the following materials contained in the Submission. Each page of the following materials (the “Confidential Materials”) is marked with the statement “Confidential Treatment Requested by Polymarket US,” pursuant to Section 145.9(d) of the Commission’s regulations, as follows:

Attachment B – First Round Election Winner Contracts: United States Senate (FREWCUSS) – 40.2 Submission

Pursuant to Section 8(a) of the CEA and 145.9(d) of the Commission’s regulations, the Exchange requests confidential treatment of the Confidential Materials under the Freedom of Information Act on the grounds that disclosure of such materials would reveal trade secrets and/or confidential commercial information of the Exchange. The Confidential Materials are proprietary to the Exchange and contain highly sensitive and confidential business information. In addition to violating the Exchange’s proprietary rights, the disclosure of Confidential Materials would grant competitors an unfair competitive advantage and/or compromise the competitive advantages possessed by the Exchange. Accordingly, we ask that you take appropriate steps to keep the Confidential Materials confidential and that you restrict the redistribution of the Confidential Materials.

Pursuant to 145.9(d)(5) of the Commission’s regulations, the Exchange hereby requests that the Confidential Materials be afforded confidential treatment in perpetuity. The Exchange requests that the Commission notify the undersigned immediately after receiving any Freedom of Information Act request, any court order, subpoena, or summons seeking to access the Confidential Materials in whole or in part. The Exchange further requests notification (through the undersigned) in the event the Commission intends to disclose the Confidential Materials in whole or part. The Exchange does not waive its notification rights under Section 8(f) of the CEA with respect to any subpoena or summons with respect to the confidential materials in whole or in part.
