Dear Mr. Kirkpatrick:

Chicago Mercantile Exchange Inc. ("CME") and The Board of Trade of the City of Chicago, Inc. ("CBOT") (collectively, the "Exchanges") certify to the Commodity Futures Trading Commission ("CFTC" or "Commission") amendments to the listing schedule of various CME and CBOT options on equity index futures contracts (the "Contracts") for trading on the CME Globex electronic trading platform ("CME Globex") and for submission of clearing via CME ClearPort effective Sunday, November 20, 2022 for trade date Monday, November 21, 2022.

Currently, the Exchanges list the next European-style options contract either on the same day of the expiration of the expiring contract or one business day following the expiration of the expiring contract. Upon implementation of the Rule Amendments, the Exchanges will uniformly list a new options contract two business days prior to the expiration of the expiring option contract for all European-style options contracts listed in Exhibit 1.

The Rule Amendments are intended to provide greater flexibility for market participants by providing access to expiries on Tuesdays and Thursdays for a five-week period, in sync with related Monday, Wednesday, and Friday expiries. Additionally, new end-of-month expiries will provide market participants with access to European-style contracts over a longer time horizon.

The Exchanges reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA" or "Act") and identified that the Rule Amendments may have some bearing on the following Core Principles:

<u>Availability of General Information</u>: The Exchanges will release a Special Executive Report ("SER") regarding these amendments. The SER will also be posted on the CME Group website.

<u>Daily Publication of Trading Information</u>: The Exchanges will continue to publish contract trading volumes, open interest levels, and price information daily on its website and through quote vendors for the Contracts.

<u>Prevention of Market Disruption</u>: Trading in the Contracts will continue to be subject to the rules of the Exchanges, which include prohibitions on manipulation, price distortion, and disruption to the cash settlement process.

<u>Compliance with Rules</u>: The Exchanges will continue its normal practice to establish, monitor, and enforce compliance with the rules of the Contracts, including the expansion of the listing schedule of the Contracts.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchanges hereby certify that the Rule Amendments comply with the Act, including regulations under the Act. There were no substantive opposing views to the proposal.
