Pursuant to Section 5c(c) of the Commodity Exchange Act and Section 40.2(a) of the regulations of the Commodity Futures Trading Commission, KalshiEX LLC (Kalshi) hereby notifies the Commission that it is self-certifying the “Will weight loss drug prescriptions grow by more than <percent> in <quarter>?” contract (Contract). The Exchange intends to list the contract on a quarterly basis. The Contract’s terms and conditions (Appendix A) includes the following strike conditions:

- <quarter> (the target quarter)
- <percent> (the target growth in the number of weight loss drugs prescribed)

CONCISE EXPLANATION AND ANALYSIS OF THE PRODUCT AND ITS COMPLIANCE WITH APPLICABLE PROVISIONS OF THE ACT, INCLUDING CORE PRINCIPLES AND THE COMMISSION'S REGULATIONS THEREUNDER

Pursuant to Commission Rule 40.2(a)(3)(v), the following is a concise explanation and analysis of the product and its compliance with the Act, including the relevant Core Principles, and the Commission's regulations thereunder.

I. Introduction

The “Will weight loss drug prescriptions grow by more than <percent> in <quarter>?” Contract is a contract relating to the number of prescriptions for novel weight loss drugs. After careful analysis, Kalshi (hereafter referred to as “Exchange”) has determined that the Contract complies with its vetting framework.

In 2021, the U.S. Food and Drug Administration began approving a small number of drugs that contain the molecules semaglutide and tirzepatide for treating obesity. These drugs were previously used to treat type II diabetes, a weight-related condition. Since then, they have been widely covered in the popular press and prescriptions have dramatically increased.¹²

IQVIA, the Contract’s Source Agency, is a major data provider in the pharmaceutical industry. It is widely regarded as not just the industry standard, but the largest player—its success in the industry is described as having “no peer”.³ They supply data regularly to the U.S. Food and Drug Administration; according to the Administration, “...FDA regularly utilizes multiple IQVIA data streams. IQVIA also provides data to other federal agencies including the Drug Enforcement Administration (DEA), and other agencies within the U.S. Department of Health and Human Services (HHS).”

Further information about the Contract, including an analysis of its risk mitigation and price basing utility, as well as additional considerations related to the Contract, is included in Confidential Appendices B, C, and D.

Pursuant to Section 5c(c) of the Act and CFTC Regulations 40.2(a), the Exchange hereby certifies that the listing of the Contract complies with the Act and Commission regulations under the Act.

General Contract Terms and Conditions: The Contract operates similar to other event contracts that the Exchange lists for trading. The minimum price fluctuation is \$0.01 (one cent). Price bands will apply so that Contracts may only be listed at values of at least \$0.01 and at most \$0.99. Further, the Contract is sized with a one-dollar notional value and has a minimum price fluctuation of \$0.01 to enable Members to match the size of the contracts purchased to their economic risks. The Exchange has further imposed position limits (defined as maximum loss exposure) of \$25,000 USD on the Contract. As outlined in Rule 5.12 of the Rulebook, trading shall be available at all times outside of any maintenance windows, which will be announced in advance by the Exchange. Members will be charged fees in accordance with Rule 3.6 of the Rulebook. Fees are charged in such amounts as may be revised from time to time to be reflected on the Exchange's Website. A new Source Agency can be added via a Part 40 amendment. All instructions on how to access the Underlying are non-binding and are provided for convenience only and are not part of the binding Terms and Conditions of the Contract. They may be clarified at any time. Furthermore, the Contract's payout structure is characterized by the payment of an absolute amount to the holder of one side of the option and no payment to the counterparty. During the time that trading on the Contract is open, Members are able to adjust their positions and trade freely. After trading on the Contract has closed, the Expiration Value and Market Outcome are determined. The market is then settled by the Exchange, and the long position holders and short position holders are paid according to the Market Outcome. In this case, "long position holders" refers to Members who purchased the "Yes" side of the Contract and "short position holders" refers to Members who purchased the "No" side of the Contract. If the Market Outcome is "Yes," meaning that weight loss drug prescription growth is above <percent> in <quarter> then the long position holders are paid an absolute amount proportional to the size of their position and the short position holders receive no payment. If the Market Outcome is "No," then the short position holders are paid an absolute amount proportional to the size of their position and the long position holders receive no payment. Specification of the circumstances that would trigger a Market Outcome of "Yes" are included below in the section titled "Payout Criterion" in Appendix A.

APPENDIX A – CONTRACT TERMS AND CONDITIONS

**Official Product Name: Will weight loss drug prescriptions grow by more than <percent>
in <quarter>?**

Rulebook: WEIGHTDRUGSQ

WEIGHTDRUGSQ

Scope: These rules shall apply to this contract.

Underlying: The Underlying for this Contract is the growth in prescriptions of products with combined molecules semaglutide and/or tirzepatide for <quarter> compared to the previous quarter according to IQVIA. Revisions to the Underlying made after Expiration will not be accounted for in determining the Expiration Value.

Source Agency: The Source Agency is IQVIA.

Type: The type of Contract is an Event Contract.

Issuance: The Contract will be issued on a quarterly basis.

<percent>: Kalshi may list iterations of the Contract with <percent> levels that fall within an inclusive range between -1000 and 1000 at consecutive increments of <0.01>. Due to the potential for variability in the Underlying, the Exchange may modify <percent> levels in response to suggestions by Members.

<quarter>: <quarter> refers to a fiscal quarter (three-month period) specified by Kalshi. Kalshi may list iterations of the Contract corresponding to variations of <quarter>.

Payout Criterion: The Payout Criterion for the Contract encompasses the Expiration Values that are above <percent>.

Minimum Tick: The Minimum Tick size for the referred Contract shall be \$0.01.

Position Limit: The Position Limit for the \$1 referred Contract shall be \$25,000 per Member.

Last Trading Date: The Last Trading Date of the Contract will be the day before the expected data release of date. Data is expected to be released the second Wednesday of the month that ends <quarter>. The Last Trading Time will be 11:59 PM ET.

Settlement Date: The Settlement Date of the Contract shall be no later than the day after the Expiration Date, unless the Market Outcome is under review pursuant to Rule 7.1.

Expiration Date: The Expiration Date of the Contract shall be the sooner of the date of the first 10:00 AM ET following the release of the data for all of <quarter>, or one month after <quarter> has ended.

Expiration time: The Expiration time of the Contract shall be 10:00 AM ET.

Settlement Value: The Settlement Value for this Contract is \$1.00.

Expiration Value: The Expiration Value is the value of the Underlying as documented by the Source Agency on the Expiration Date at the Expiration time.

Contingencies: Before Settlement, Kalshi may, at its sole discretion, initiate the Market Outcome Review Process pursuant to Rule 6.3(c) of the Rulebook.
