Dear Mr. Kirkpatrick:

The Board of Trade of the City of Chicago, Inc. ("CBOT" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying the delisting of previously listed contract months beyond December 2014 for the Dow Jones Industrial Average Index Futures (\$25 Multiplier) contract effective immediately as set out in the table below. The contract months slated to be delisted have no open interest.

The futures contract details are as follows:

<b>Stock Index Product</b>	<b>Rulebook Chapter</b>	<b>Commodity Code</b>
CBOT Dow Jones Industrial Average Index Futures (\$25 Multiplier)	CBOT 28	DD (CME Globex) DO (Clearing and CBOT floor)

CBOT business staff and the CBOT Legal Department collectively reviewed the designated contract market core principles ("Core Principles") as set forth in the Commodity Exchange Act ("CEA" or "Act"). During the review, CBOT staff identified that the delisting of the contract months may have some bearing on the following Core Principles:

- **Emergency Authority**: There is no open interest in the previously listed contract months submitted for delisting, and therefore there will be no market disruption related to their delisting.
- **Availability of General Information**: The Exchange will make publicly available the details of the contract months delisting by publishing a notice to the market. Furthermore, the Exchange will update the CBOT rulebook to reflect the delisting of the contract months.

Pursuant to Section 5c(c) of the Act and CFTC Regulation 40.6(a), the Exchange hereby certifies that the delisting of the contract months comply with the Act, including regulations under the Act. No substantive opposing views to these amendments were expressed to the Exchange.
