RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strike Levels in Certain Binary Contracts on October 20 and 23, 2014 – Submission Pursuant to Commission Regulation §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended (“Act”), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the “Commission”) under the Act (the “Regulations”), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. (“Nadex”, the “Exchange”) hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex has added additional strike levels on a discretionary basis in its Weekly Jobless Claims Binary Contracts on October 20, 2014. Nadex plans to return to its regular listing for this contract on Monday October 27, 2014. Nadex also added additional strikes in its Daily US Tech 100, Wall Street 30, and US SmallCap 2000 Binary Contracts on October 23, 2014. Nadex returned to its regular listing schedule for these contracts on October 24, 2014.

New strikes created on October 20 and 23, 2014 are set forth in Exhibit A.

Nadex hereby certifies that the additions contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder.
