RE: Weekly Notification of Rule Amendments: Nadex Adds Discretionary Strikes for December 15, 17, and 18, 2015 - Submission Pursuant to Commission Reg. §40.6(d)

Dear Mr. Kirkpatrick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that due to volatility in the underlying markets upon which the Nadex contracts are based, Nadex added additional strike levels on a discretionary basis in its Daily Wall Street 30 and US Tech 100 Binary contracts on December 15, 2015. Nadex returned to its regular listing for these contracts on December 16, 2015. Nadex also added discretionary strikes in its Daily US Tech 100, Gold, and Silver Binary contracts on December 17, 2015. Finally, Nadex listed discretionary strikes in its Daily US Tech 100, Wall Street 30, Gold, and Silver Binary contracts on December 18, 2015 due to volatility in the underlying market upon which these contracts are based. Nadex plans to return to its regular listing schedule for these contracts on December 21, 2015. Additional strikes are attached hereto in Exhibit A.

Nadex hereby certifies that the additions and amendments contained herein comply with the Act, as amended, and the Commission Regulations adopted thereunder. No substantive opposing views were expressed to Nadex with respect to these additions. Nadex hereby certifies that notice of these events was posted on its website at the time of this filing.
