#### Terms and definitions

Exchange – Public Joint-Stock Company "Moscow Exchange MICEX-RTS"

**EDI Rules** – Electronic Data Interchange Rules.

**Trading Member** – a legal entity included, in compliance with the Exchange internal documents in Trading Members to effect transactions on organised trading conducted by the Exchange.

#### SECTION I. GENERAL PROVISIONS

This Procedure for Submission of Information and Reports to Public Joint-Stock Company "Moscow Exchange MICEX-RTS" (hereinafter – the Procedure) is developed in accordance with the requirements of the laws and regulations of the Russian Federation/Regulative instruments of the Bank of Russia, the Charter and other internal documents of the Exchange.

- 1.1. The Procedure determines the composition, the deadlines for and the formats of submitting Information and Reports
  - 1.1.1. by Trading Members and Members that effect operations using the trading system of the Exchange in deposit and/or credit transactions, auctions, order selection for depositing cash funds (hereinafter the Members);
  - 1.1.2. by Trading Member/Member Candidates when the Admission Rules and/or other internal documents of the Exchange require that Trading Member/Member Candidates should submit Information and Reports to the Exchange in compliance with this Procedure.
- 1.2. Information and Reports shall be submitted by Trading Members/Members to the Exchange for the following purposes:
  - 1.2.1. Development and update of the data base with information on Trading Members/Members;
  - 1.2.2. Supervision over Trading Members, including compliance thereof with the requirements to their financial state with a view to reduce risk in organised trading.
- 1.3. All Appendices hereto shall be an integral part hereof.
- 1.4. This Procedure and all Amendments hereto shall be approved by the Exchange and shall become effective from the date specified by the Exchange.
- 1.5. Information on approval of this Procedure (Amendments and Supplements hereto), entry into force thereof as well as the text of the Procedure (Amendments and Supplements) shall be disclosed on the Exchange website no later than five (5) business days prior to the effective date, unless otherwise provided for by decision of the Exchange.
- 1.6. Any terms not expressly defined herein have the meanings ascribed to them by the laws and regulations of the Russian Federation, regulative instruments of the Bank of Russia, Charter of the Exchange, Trading Rules, Admission Rules and other internal documents of the Exchange.

## SECTION II. INFORMATION TO BE SUBMITTED BY TRADING MEMBERS/MEMBERS TO THE EXCHANGE

- 2.1. Information to be submitted by Trading Members/Members to the Exchange in compliance herewith shall include the Registration Card which form is provided in Appendix No. 1 hereto.
- 2.2. The Exchange shall have the right to request additional information from the Trading Member/Member, including the information characterizing financial state thereof.
- 2.3. The Exchange shall store the Information for at least five years after the commitments between the Exchange and the Trading Member/Member are discontinued.
- 2.4. Trading Members/Members shall be obligated to secure relevancy and authenticity of data contained in the Information submitted thereby to the Exchange.

## SECTION III. REPORTS TO BE SUBMITTED BY TRADING MEMBERS AND MEMBERS TO THE EXCHANGE

3.1. Reports to be submitted by Trading Members to the Exchange shall include:

- Reports by credit institutions complied according to Forms 0409051, 0409101, 0409102, 0409123, 0409135 in compliance with Instructions by the Bank of Russia dated 12 November 2009 No. 2332-U "On List, Forms and Procedure for Compiling and Submitting Reports Forms of Credit Institutions to the Central Bank of the Russian Federation", and a statement on the numeric value of the ratio of single borrower or group of related party borrowers risk (N6) (based on data in Form 0409118);
- Reports by non-credit institutions that are professional securities market participants compiled according to Forms 0420402, 0420403, 0420408, 0420410, 0420411, 0420412, 0420415, 0420416, 0420417, 0420418, 0420421 in compliance with Instruction by the Bank of Russia dated 15.01.2015 No. 3533-U "On Deadlines and Procedure for Compiling and Submitting of Reports by Professional Securities Market Participants to the Central Bank of the Russian Federation"; a calculation of equity according to the form established by Order of the FFMS of Russia dated 23 October 2008 No. 08-41/pz-n\_Instruction of the Bank of Russia dated 19.07.2016 No. 548-P;
- Reports by non-credit institutions other than professional securities market participants complied according to Forms 0710001, 0710002 in compliance with order of the RF Ministry of Finance dated 2 July 2010 No. 66n "On Forms of Accounting Reporting by Organisations".
- Reports by state corporations and international organisations compiled according to Forms 0409101, 0409102, 0409123 in compliance with Instruction by the Bank of Russia dated 12 November 2009 No. 2332-U "On List, Forms and Procedure for Compiling and Submitting Reports Forms of Credit Institutions to the Central Bank of the Russian Federation".
- Reports by non-resident banks
  - IFRS financial statements in Russian or in English, in absence thereof, balance sheet (or a turnover balance sheet), income statement and calculation of equity (capital) (if any) in accordance with established national accounting and reporting standards shall be submitted quarterly;
  - major performance indicators for a Non-Resident (according to the Form of Appendix No. 3 to the Procedure) shall be submitted quarterly;
  - document confirming information about actual and permissible values of mandatory ratio
    of activity set by a competent body, if such mandatory ratios shall be set pursuant to the
    national legislation of the state of the non-resident bank's incorporation shall be submitted
    quarterly;
  - IFRS financial statements in Russian or in English for the latest reporting year, certified by auditor, in absence thereof, audited financial statements compiled in accordance with requirements of the national legislation of the state of the non-resident bank's incorporation shall be submitted annually.
- 3.2. Reports by credit and non-credit institutions, by state corporations and international organisations, and by non-resident banks to be submitted thereunder shall be jointly referred to as Reports.
- 3.3. The Exchange shall have the right to request supplementary statements not specified herein from Trading Members.
- 3.4. Reports shall be stored for 5 years.
- 3.5. Trading Members shall be obligated to secure relevancy and authenticity of data contained in the Information submitted thereby.

#### SECTION IV. DEADLINES FOR SUBMISSION OF INFORMATION TO THE EXCHANGE BY TRADING MEMBERS AND MEMBERS

- 4.1. The Registration Card shall by submitted to the Exchange by the Trading Member/Members at least once every six months with the current data as of the date of submission thereof for the following periods:
  - from the first business day of the calendar year to 31 January of the same year;
  - from the first business day of July to 31 July of the current year.

- 4.2. In an event the data in the Registration Card changes, the Trading Member/Member shall be obligated to notify the Exchange of said changes within five (5) business days of the day of such changes by submitting an updated Registration Card in compliance with the requirements of Section VI hereof. Documents supporting the said changes shall be submitted to the Exchange in compliance with the Exchange internal documents.
- 4.3. As and when required the Exchange shall have the right to request Trading Members/Members to submit the Registration Card at any time. In such an event the Registration Card must be submitted within the timeline specified in the relevant request and, where such a timeline is not specified within ten (10) business days of the receipt of such a request.

## SECTION V. FREQUENCY AND DEADLINES FOR SUBMISSION OF REPORTS TO THE EXCHANGE BY TRADING MEMBERS

- 5.1. Reports by credit institutions:
  - Trial balance according to the accounts of the credit institution (Form 0409101) shall be submitted on a monthly basis.
  - Income statement (Form 0409102) shall be submitted on a quarterly basis.
  - Calculation of equity (capital) (BASEL III) (Form 0409123) shall be submitted on a monthly basis.
  - Information on the mandatory ratios (Form 0409135) shall be submitted on a monthly basis,
  - Statement on numerical value of the ratio of single borrower or group of related party borrowers risk (N6) (based on data in Form 0409118) shall be submitted on a monthly basis.
  - Affiliated Parties List (Form 0409051)<sup>1</sup> shall be submitted on a quarterly basis.

Reports by credit institutions shall be submitted no later than business day fifteen (15) of the month following the reporting month or the reporting quarter.

5.2. Reports by credit institutions that are professional securities market participants:

- Balance sheet (Form 0420410), statement of financial results (Form 0420411), information on the largest debtors and creditors of the professional participant (Form 0420412), information about portfolio investments in securities issued by non-residents (Form 0420416)<sup>2</sup>, statement of the flow of foreign assets and liabilities of the professional participant in relation to non-residents if the latter and the non-residents have a direct investment relationship (Form 0420421)<sup>3</sup>, information on affiliates of the professional participant (Form 0420402)<sup>4</sup>, information on affiliates belonging to the same group with the professional participant (Form 0420403)<sup>5</sup> shall be submitted on a quarterly basis;

- Calculation of equity (capital), information on participation in legal proceedings where the professional participant is a defendant (Form 0420408)<sup>6</sup>, report on securities (Form 0420415),

Reports by credit institutions that are professional securities market participants shall be submitted no later than one calendar month following the reporting month or the reporting quarter. Non-credit institutions being professional securities market participants shall submit reports within one calendar month following the reporting month or reporting quarter. Balance sheet (Form 0420410), statement of financial results (Form 0420411), information on the largest debtors and creditors of the professional participant (Form 0420412), information about portfolio investments in securities issued by non-residents (Form 0420416), as of and including December 31, shall be submitted no later than on March 30.

- 5.3. Reports by non-credit institutions other than professional securities market participants:
  - Balance Sheet (Form 0710001) shall be submitted on a yearly basis;
  - Income Statement (Form 0710002) shall be submitted on a yearly basis.

Reports by non-credit institutions other than professional securities market participants shall be submitted no later than business day fifteen (15) of April of the year following the reporting one.

- 5.4. Reports by state corporations and international organisations:
  - Trial balance according to the accounts of the credit institution (Form 0409101) shall be submitted on a monthly basis;
  - Income statement (Form 0409102) shall be submitted on a quarterly basis;
  - Calculation of equity (capital) (BASEL III) (Form 0409123) shall be submitted on a monthly basis.

Reports by state corporations and international organisations shall be submitted no later than business day fifteen (15) of the month following the reporting month or the reporting quarter.

- 5.5. Reports by non-resident banks:
  - IFRS financial statements in Russian or in English, in absence thereof, balance sheet (or a turnover balance sheet), income statement and calculation of equity (capital) (if any) in accordance with established national accounting and reporting standards shall be submitted on a quarterly basis;
  - Major performance indicators for a non-resident bank (according to the Form of Appendix No. 3 to the Procedure shall be submitted on a quarterly basis;
  - Document confirming information about actual and permissible values of mandatory ratio of activity set by a competent body, if such mandatory ratios shall be set pursuant to the national legislation of the state of the non-resident bank's incorporation shall be submitted on a quarterly basis;
  - IFRS financial statements in Russian or in English for the latest reporting year, certified by auditor, in absence thereof, audited financial statements compiled in accordance with requirements of the national legislation of the state of the non-resident bank's incorporation shall be submitted annually.

Non-resident banks shall submit the reports no later than on the 15<sup>th</sup> (fifteenth) business day from the date of submission of quarterly reports, respectively, or from the date determined by the competent body of the state of the non-resident bank's incorporation as the date for submission of quarterly reports,

information about participation in legal proceedings where the professional participant was a defendant, submitted to the Bank of Russia.

respectively (if the report submission deadlines are set by the competent body of the state of the nonresident bank's incorporation), with the following exception: IFRS financial statements for the latest reporting year, certified by auditor, in absence thereof, audited financial statements compiled in accordance with requirements of the national legislation of the state of the non-resident bank's incorporation, shall be submitted no later than on the 15<sup>th</sup> (fifteenth) business day from the date on which such statements were signed by the auditor.

## SECTION VI. PROCEDURE FOR COMPILING AND SUBMISSION OF INFROMATION AND REPORTS

- 6.1. Information and Reports submitted to the Exchange by Trading Members/Members in compliance herewith shall be compiled taking into account the following requirements:
  - 6.1.1. Reports by credit institutions, state corporations and international organisations shall be prepared in the following way:
    - Reports compiled in compliance with Forms: 0409051, 0409101, 0409102, 0409123, 0409135 shall be submitted in the format corresponding to that of files formed in the KLIKO software (submitted to the Moscow Main Territorial Department of the Bank of Russia or the TC's SHC (submitted to the Territorial Department of the Bank of Russia).
    - Reports compiled in accordance with Form 0409118 a statement on numerical value of the ratio of single borrower or group of related party borrowers risk (N6) shall be submitted as an XML file formed in ARFA software, posted on the Exchange website (www.moex.com).
  - 6.1.2. Reports by credit institutions that are professional securities ,market than shall be prepared in the following way:
    - Reports compiled in accordance with the forms 0420402, 0420403, 0420408, 0420410, 0420411, 0420412, 0420415, 0420416, 0420417, 0420418, 0420421 are presented in form of XML files (with \*.xtdd extension) generated in the Program-Questionnaire for Generation of Electronic Documents, provided by the Bank of Russia.
    - Calculation of equity is provided in form of an XML file files (with \*.xtdd extension) generated in PROFY software.
  - 6.1.3. Reports by credit institutions other than credit institutions shall be prepared in the following way
    - Reports compiled in compliance with Forms 0710001, 0710002 shall be submitted as an XML format file generated in PROFY software posted on the Exchange website (www.moex.com) or as a swap file (XML format), formed for electronic transmission of data on accounting reporting to tax authorities.
  - 6.1.4. Reports by non-resident banks shall be prepared in the following way:
    - IFRS financial statements; balance sheet (trial balance sheet), income statement and calculation of equity (capital) in accordance with established national accounting and reporting standards; document confirming information about actual and permissible values of mandatory ratio activity set by a competent body shall be submitted in the format corresponding to the format of the file generated in a report preparation software for the purpose of submission to the regulatory bodies of the non-resident bank's incorporation;
    - Major performance indicators for a non-resident bank for the reporting quarter according to the Form of Appendix No. 3 (text format with tabulation separators)) to the Procedure.
- 6.2. The Registration Card shall be submitted as an XML file, formed by the Registration Card software posted on the Exchange website (<u>www.moex.com</u>).
- 6.3. The Registration Card and Reports shall be submitted by Trading Members/Members to the Exchange in the form of electronic documents in an appropriate format.

- 6.4. Submission of the Registration Card and Reports in the form of electronic documents shall be effected by Trading Members/Members that have signed an Agreement with the Exchange on participation in the Electronic Documentary Circulation System and have been authorised to effect an electronic documentary circulation in compliance with the EDI Rules and meeting the following requirements:
  - 6.4.1. When the Registration Card or Reports are sent electronic document, the files contained therein must be included in the electronic document in the form they were generated by the documenter in compliance with sub-clause 6.1 hereof. The electronic document must be signed by the Trading Member/Members in compliance with the EDI Rules of the Exchange.
  - 6.4.2. The Registration Card and Reports submitted to the Exchange in the form of electronic documents are assigned to the G category of documents in compliance with the EDI Rules of the Exchange.
  - 6.4.3. The formats of electronic documents used for submitting the Registration Card and Reports in compliance with sub-clause 6.1 hereof, are provided in Appendix No. 2 hereto.
  - 6.4.4. The Registration Card and Reports in the form of electronic documents and e-mail messages shall be sent by Trading Members/Members via e- mail to the addresses of the Exchange posted on the website (<u>www.moex.com</u>).
  - 6.4.5. Based on the results of submitting electronic documents to the Exchange by Trading Members/Members, the Exchange shall send the following electronic messages to the Trading Member/Member via e-mail:
    - Notification of the electronic document receipt as a result of the delivery of the message with the Reports File attached;
    - Statement on the outcome of the Reports File processing as a result of the Reports processing;
    - Notification of the receipt of the electronic document containing the Registration Card.
  - 6.4.6. Record keeping and storage of the Registration Card and Reports received by the Exchange in the form of electronic documents shall be effected in compliance with the EDI Rules. At that, the Exchange shall secure maintenance of an electronic log of electronic documents received from Trading Members/Member as well as storage of the electronic documents per se in the electronic archive of the Exchange.
- 6.5. The Registration Card and Reports submitted by the Trading Member/Member to the Exchange shall be processed within no more than three (3) business days of the date of receipt of said documents from the Trading Member/Member.
- 6.6. In an event the Trading Member/Member submits the Registration Card and/or Reports noncompliant with the requirements hereof, the Exchange, within no more than three (3) business days of processing of the documents received, shall notify the Trading Member/Member by way of sending an e-mail message thereto, of the need to eliminate violations of the requirements hereof.
- 6.7. The date of receipt of the Registration Card and Reports shall be deemed the date of submission thereof to the Exchange by the Trading Member/Members provided they comply with the requirements hereof with respect to the composition, form and format thereof.
- 6.8. Trading Members which have branches must submit consolidated reports comprising data on the Trading Member and branches thereof compiled in compliance with the requirements of the regulatory instruments of the Bank of Russia and laws and regulations of the Russian Federation to execution of consolidated reports and requirements hereof.
- 6.9. Obligation of the Trading Member/Member to present the reports specified in this Procedure, and the Registration Card is deemed fulfilled upon submission by the Trading Member/Member of the said documents, provided that they meet the requirements as to their contents, form and format, set by the Procedure.

6.10. Where non-resident banks submit documents provided for herein, the said documents must be translated into the official language of the Russian Federation (the Russian language), the accuracy of the translation and the authenticity of the translator's signature must be notarised.

Documents executed in the territory of foreign states must be legalised or apostilled, unless otherwise provided for by international agreements of the Russian Federation.

#### **SECTION VII. FINAL PROVISIONS**

- 7.1. Trading Members/Members shall bear responsibility for invalid data and information submitted thereby as part of the Information and/or Reports as well as violations of deadlines for submission thereof in compliance with the laws and regulations of the Russian Federation, regulations of the Bank of Russia, herein and other internal documents of the Exchange.
- 7.2. Penalties levied on Trading Members/Members failing to submit Information and Reports and meet the deadlines provided hereby for submission of Information and Reports are established by internal documents of the Exchange.
