Narrative: Gil Mandelzis co-founded Traiana in April 2000 and on his appointment as Chief Executive Officer of EBS BrokerTec in March 2012, was appointed Executive Chairman of Traiana. Mr. Mandelzis led Traiana's growth from a small start-up to a recognised global leader in post trade services resulting in Traiana's acquisition by ICAP in 2007. Mr. Mandelzis was appointed to the New York Federal Reserve's Foreign Exchange Committee in 2012.



Eliran Glazer

Title: Chief Financial Officer and Treasurer

Positions held since: April 15, 2016

Narrative: Eliran Glazer was appointed Chief Financial Officer of EBS BrokerTec in September 2012. Before joining EBS BrokerTec, Mr. Glazer was Chief Financial Officer for Traiana and previously served as Director of Finance at Schema Ltd. Prior to Schema Ltd, Mr. Glazer filled the role of Controller of BackWeb Technologies, a leading provider of Proactive Portal technologies and push infrastructure for the enterprise environment. From 1997 to 2000, Mr. Glazer was at KPMG and was responsible for customers in the high-tech, communication and services industries.

Ivan Ritossa

Title: Public Director and Chairperson of Regulatory Oversight Committee

To be appointed to the Board as a Public Director and member of the Regulatory Oversight Committee prior to EBS Global Facility Limited becoming operational, once board appointment is approved by the U.K. Financial Conduct Authority.

Narrative: In 2013, Ivan Ritossa was appointed as an independent, non-executive director of ICAP plc. On August 7, 2013, Mr. Ritossa was appointed a public director and member of the regulatory oversight committee of ICAP SEF (US) LLC. Mr. Ritossa has worked in investment banking for 30 years, based in the UK, Asia and Australia. From 2011 to 2012, Mr. Ritossa was the Head of Latin America, Central and Eastern Europe, the Middle East and Africa across all products for Barclays Capital, and also represented Barclays Bank PLC as a non-executive director of the ABSA Group Board and ABSA Bank Limited. The ABSA Group Limited is listed on the Johannesburg Stock Exchange and is one of South Africa's largest banks. From 2007 to 2012, Mr. Ritossa also served on the Executive Committee for Barclays Capital. Whilst at Barclays, Mr. Ritossa also served as an executive director of Barclays Saudi Arabia, a closed joint stock company regulated by the Capital Markets Authority. Mr. Ritossa has been a member of numerous industry committees including the New York Federal Reserve Foreign Exchange Committee, The Bank of England Foreign Exchange Joint Standing Committee and the Singapore Foreign Exchange Markets Committee. He has an honours degree in Finance from the University of New South Wales, Australia.



Stuart Wexler

Positions held since: April 15, 2016

Narrative: Stuart Wexler is General Counsel of the Americas for ICAP North America Inc., responsible for management of the legal and compliance function for ICAP's U.S. and Latin American businesses. Prior to joining ICAP in April 2009, Mr. Wexler was with Merrill, Lynch, Pierce, Fenner and Smith, initially as First Vice President and Head of Fixed Income Compliance for the Global Markets and Investment Banking division, and subsequently, Managing Director and Head of Sales and Trading Compliance for that division. From 1999 to 2005, Mr. Wexler served as Managing Director and Associate General Counsel with Greenwich Capital where he was responsible for providing regulatory and compliance advice to each of the firm's fixed income businesses. Narrative: Ian Chicken is Business Transformation Director, responsible for the design and separation of post trade and electronic markets businesses including EBS and BrokerTec from within the existing ICAP Group. Mr. Chicken is also a Director of ISDX and BrokerTec Europe Limited. Previously, Mr. Chicken was Global Head of BrokerTec Direct, responsible for the design and launch of a new disclosed streaming platform for US Treasuries, and before that was Chief Operating Officer for BrokerTec and ISDX having re-joined ICAP in October 2012, focusing on market developments and new business initiatives. Prior thereto from January 2011 to September 2012, Mr. Chicken was Executive Director - Business Change at NYSE Euronext, responsible for the NYSE LIFFE Business interface to IT, both internally and externally, and also managing the Account Management team. Mr. Chicken was a Director of LIFFE Administration and Management, the Recognised Investment Exchange. Mr. Chicken worked at ICAP Electronic Broking as Chief Operating Officer from March 2000 to December 2010, working with Fixed Income Operations and IT areas across Europe to implement ICAP's electronic trading platforms and was responsible for installing and managing the group's links with Central Counterparties, Futures Exchanges and other clearing services, and was also responsible for the day-to-day running of ICAP's European Electronic Broking unit. From March 2010 to December 2010 Mr. Chicken was involved in ICAP's Post Trade businesses, particularly involved with Trioptima, Reset and Rematch. Mr. Chicken was chair of the European Repo Council's Operations Group until October 2010, responsible for reviewing settlement issues and involved in producing a White Paper on Repo issues in Europe. Mr. Chicken was a Director of Trading Cross Connects until December 2010, an infrastructure and seed capital provider for high frequency trading firms. Prior to joining ICAP, Mr. Chicken worked for HSBC from 1987 to 2000, in a variety of roles in London, Stockholm and Paris. Latterly he was Senior Manager of HSBC's Fixed Income Settlements and Futures Clearing groups.
