Industry Capacity Building

The IOSCO SRO Consultative Committee^[1] identified the following elements that might be considered in a model template for an effective SRO:

Internal rulemaking procedures

Authorization and access to a marketplace, including fitness/qualification standards for market intermediaries

Establishment and enforcement of financial, operational and sales practice standards

Surveillance of market activity

Investigation, prosecution and adjudication of rule violations

Administration of a dispute resolution forum

Development and implementation of education programs for market participants and public investors

Sharing information and cooperating with other SROs and statutory regulators
