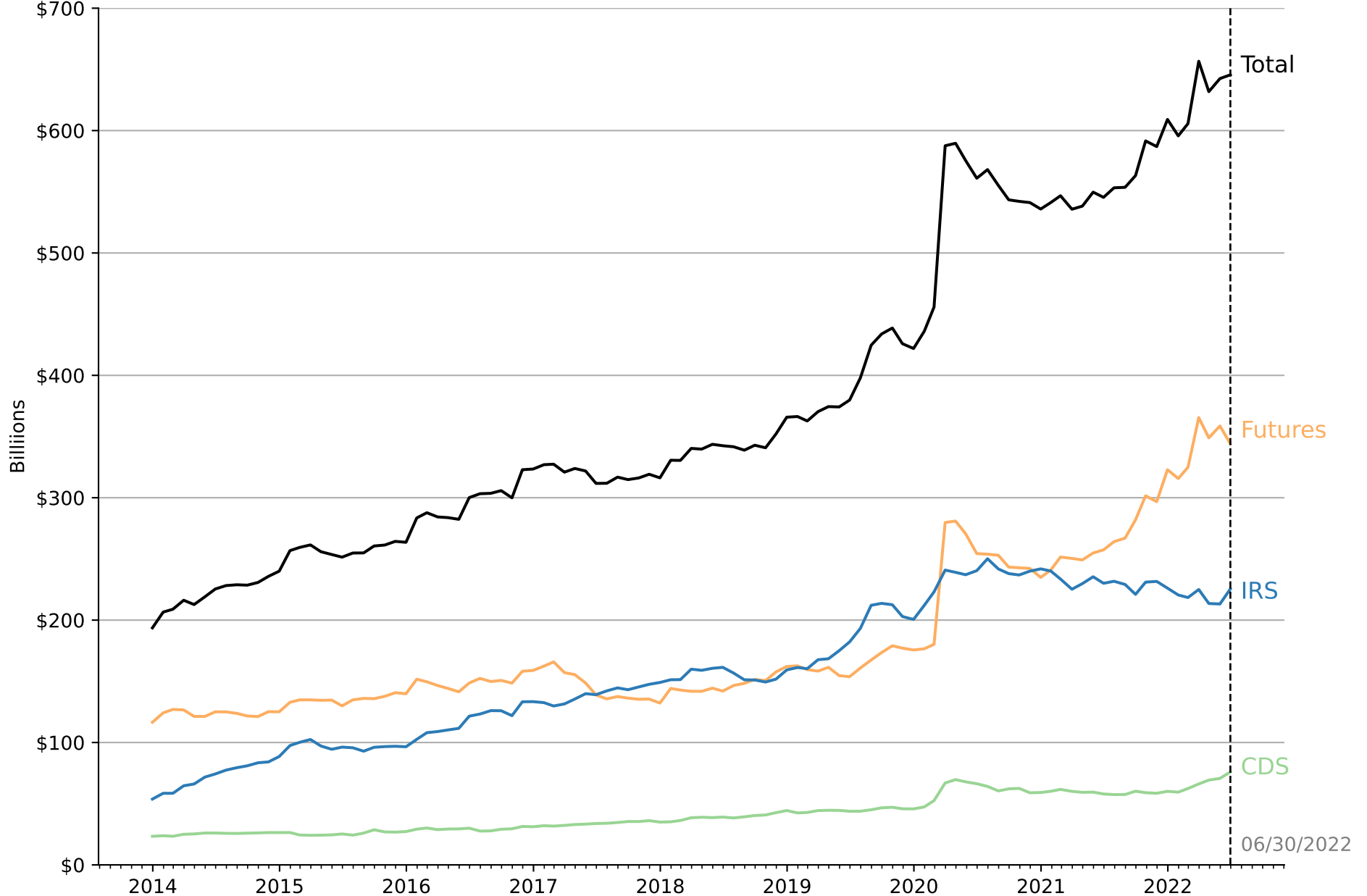

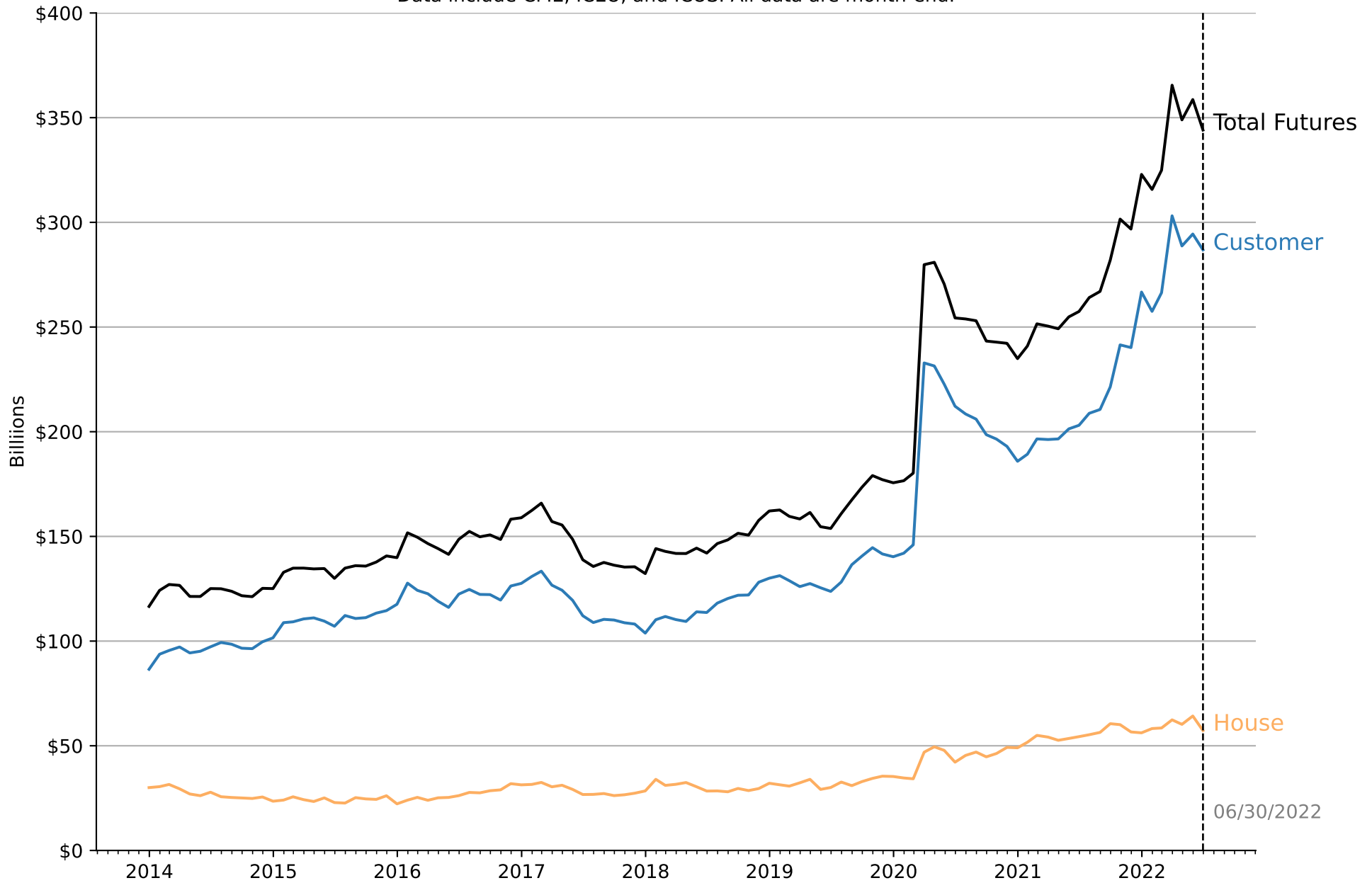

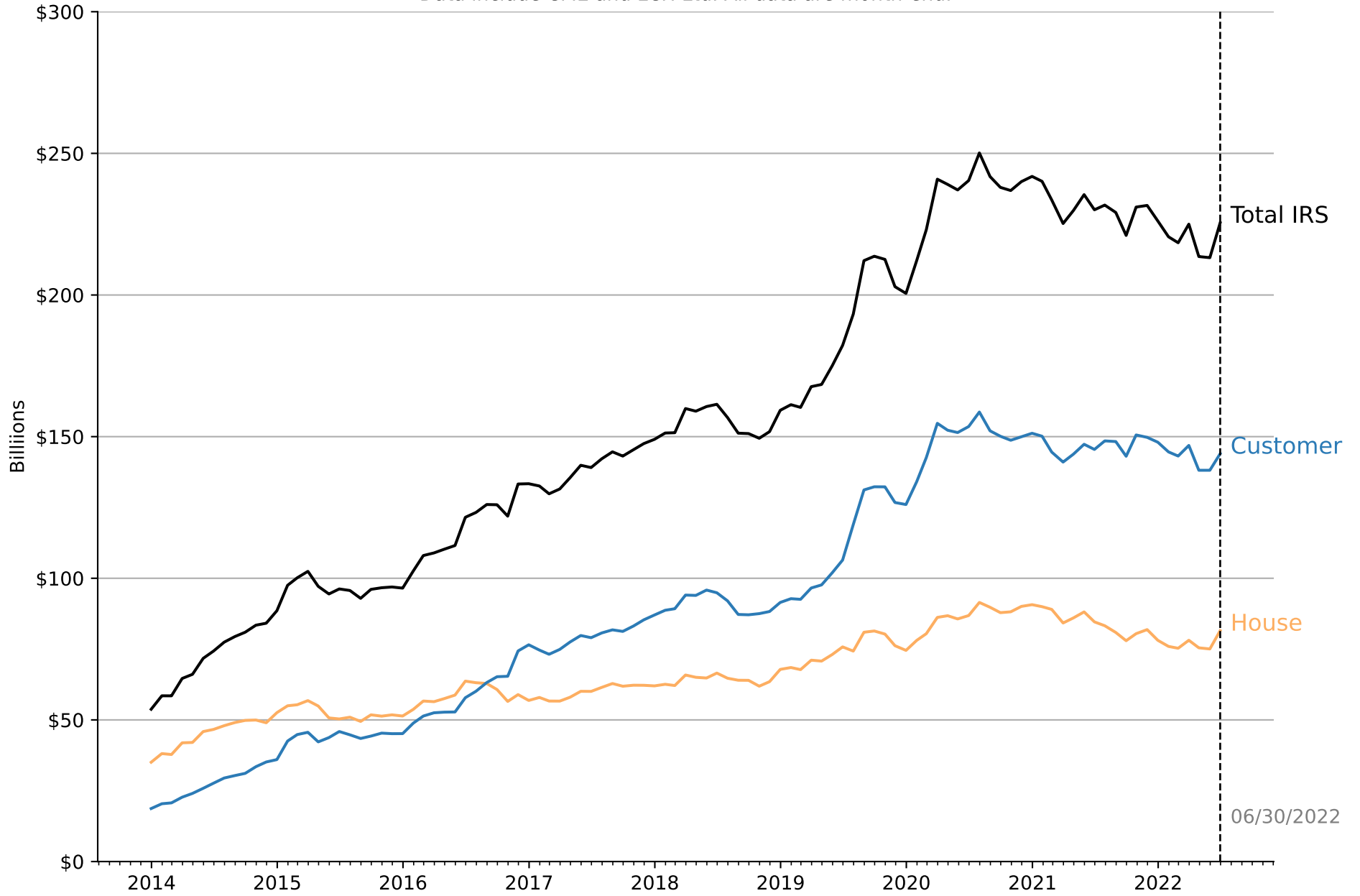
# Initial Margin Requirements - Futures

Data include CME, ICEU, and ICUS. All data are month-end.



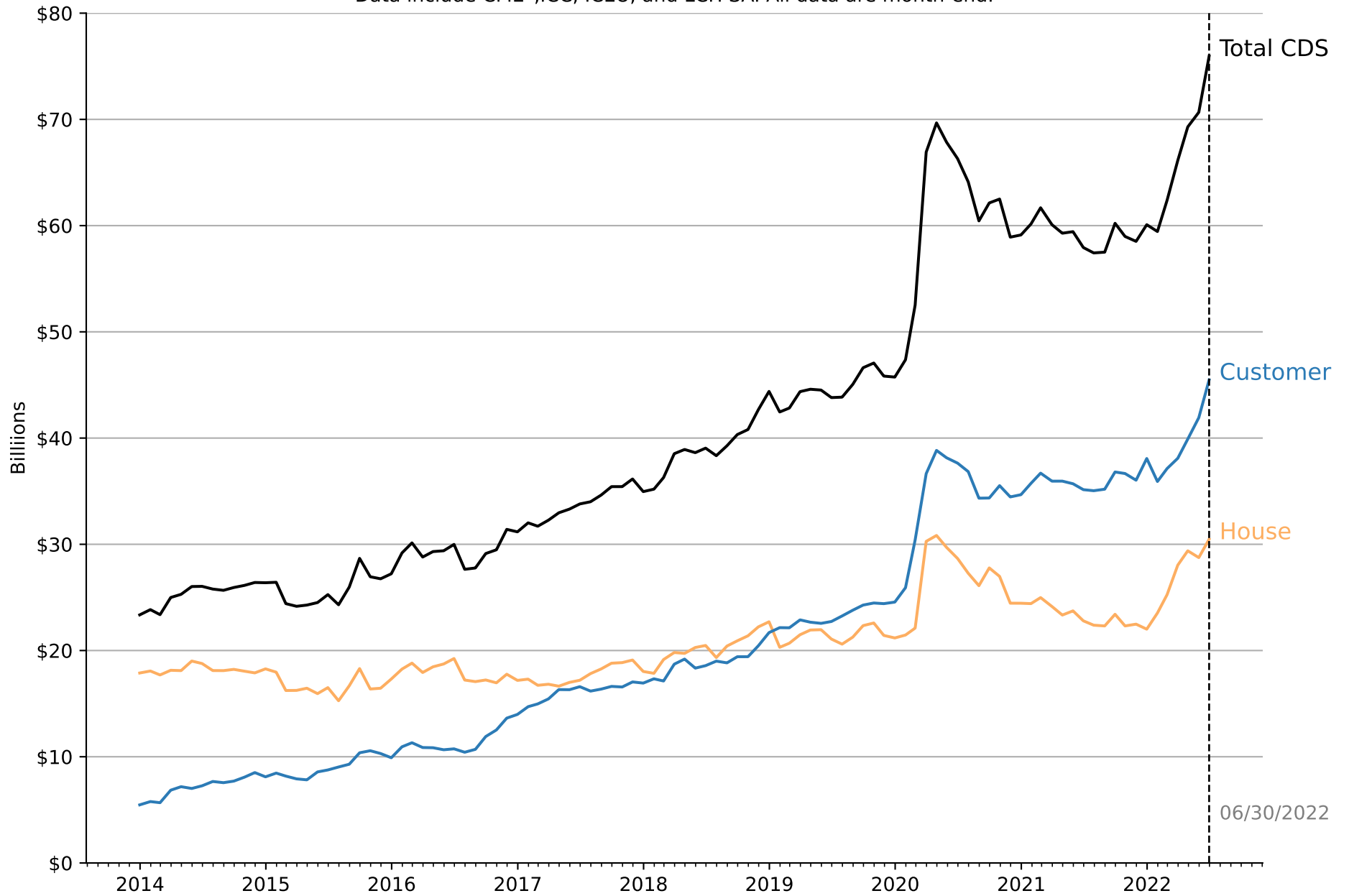
# Initial Margin Requirements - IRS

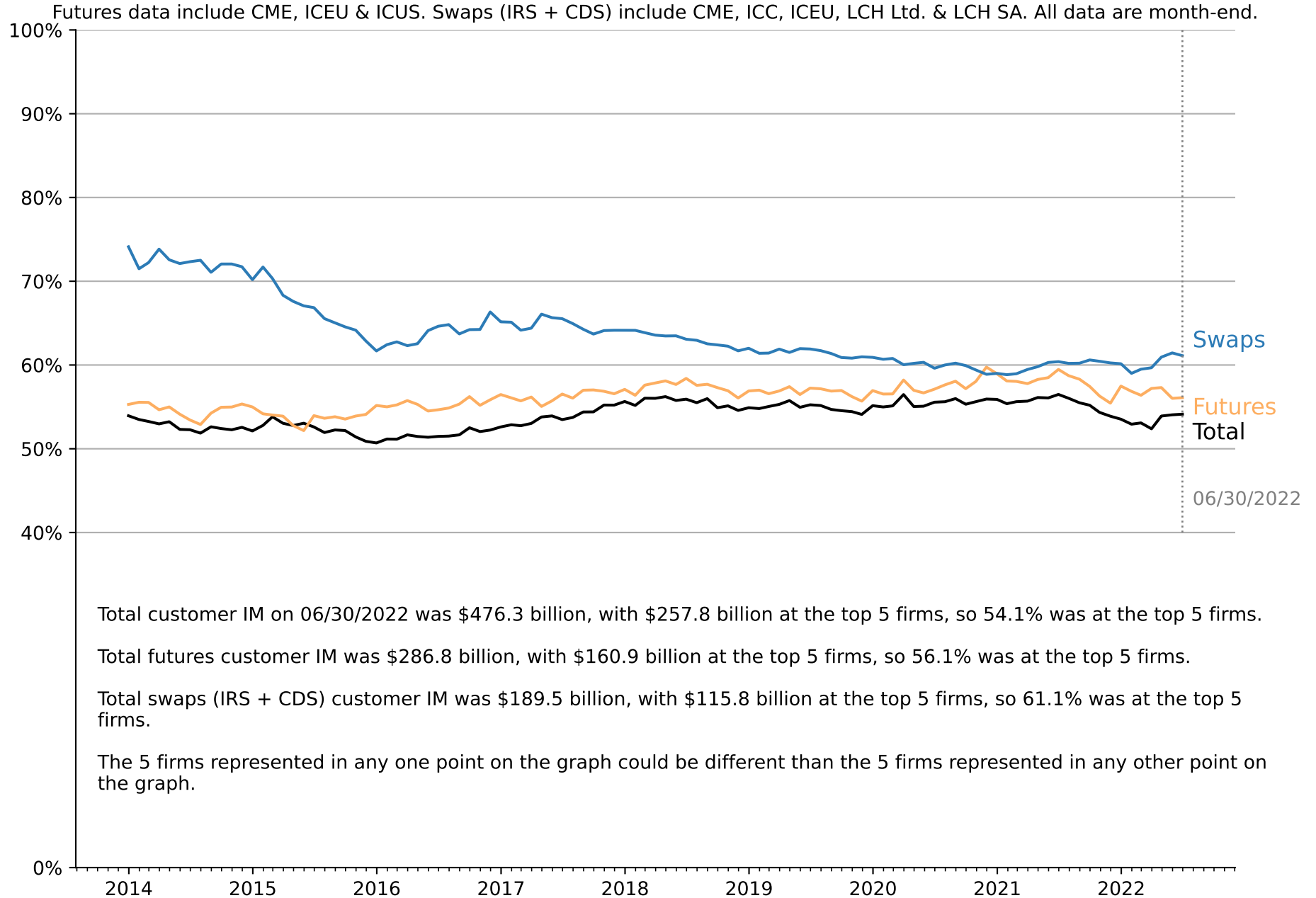
# Initial Margin Requirements - CDS

# Customer Initial Margin Requirements - Percentage at 5 Largest Parent Firms\*



Total customer IM on 06/30/2022 was \$476.3 billion, with \$257.8 billion at the top 5 firms, so 54.1% was at the top 5 firms.

Total futures customer IM was \$286.8 billion, with \$160.9 billion at the top 5 firms, so 56.1% was at the top 5 firms.

Total swaps (IRS + CDS) customer IM was \$189.5 billion, with \$115.8 billion at the top 5 firms, so 61.1% was at the top 5 firms.

The 5 firms represented in any one point on the graph could be different than the 5 firms represented in any other point on the graph.

\*Affiliated clearing members are combined into a single parent firm.
