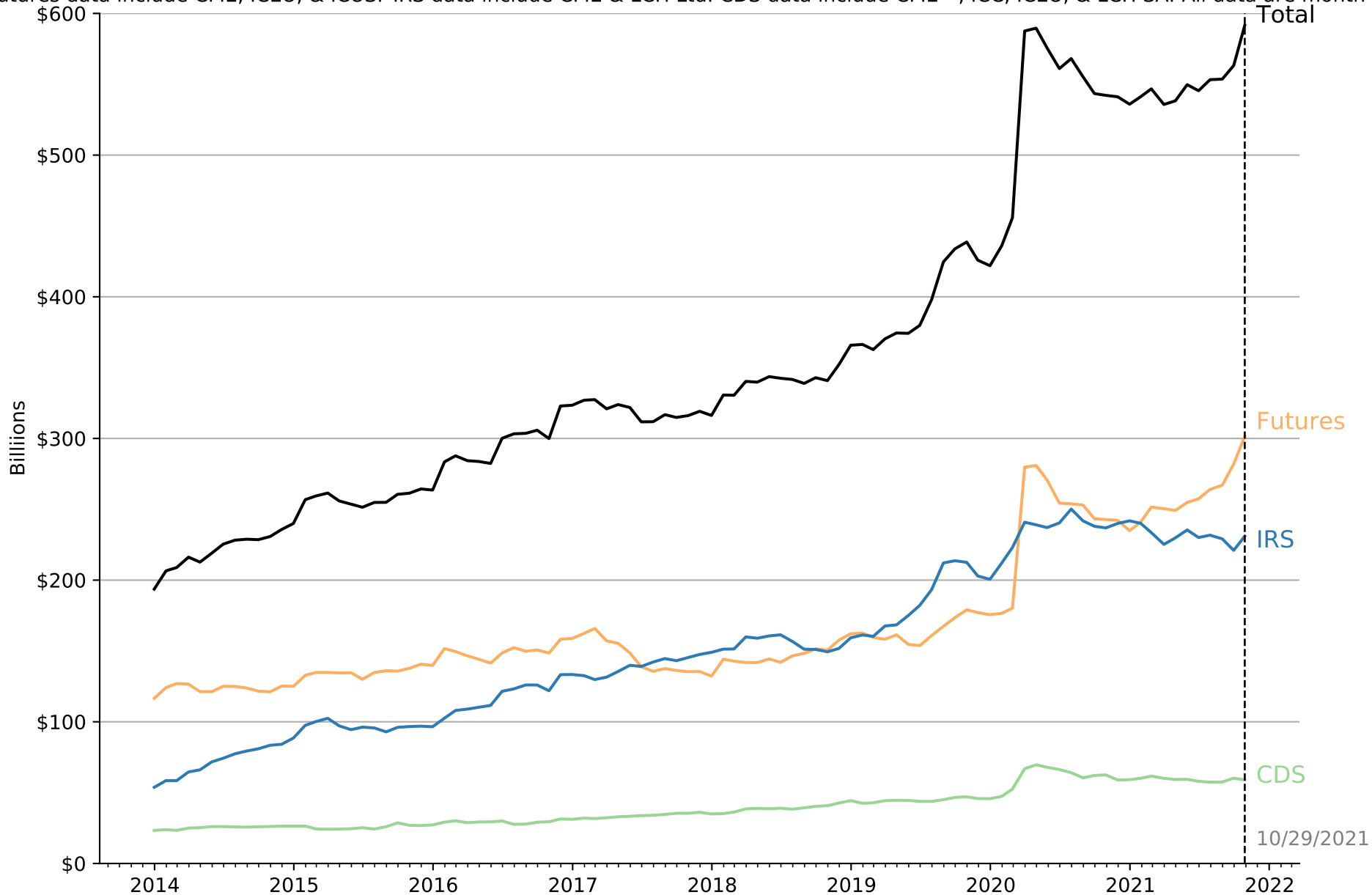

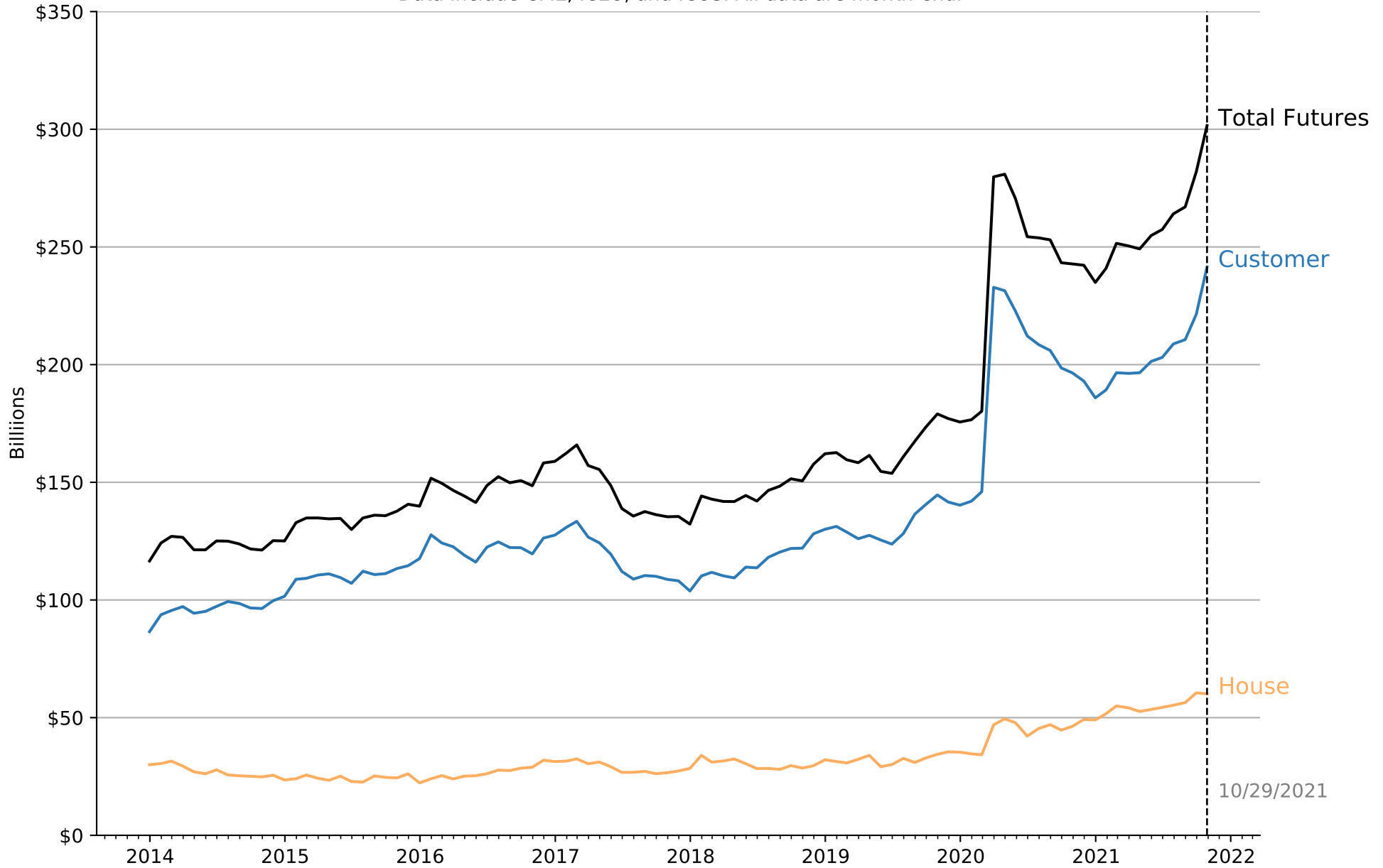

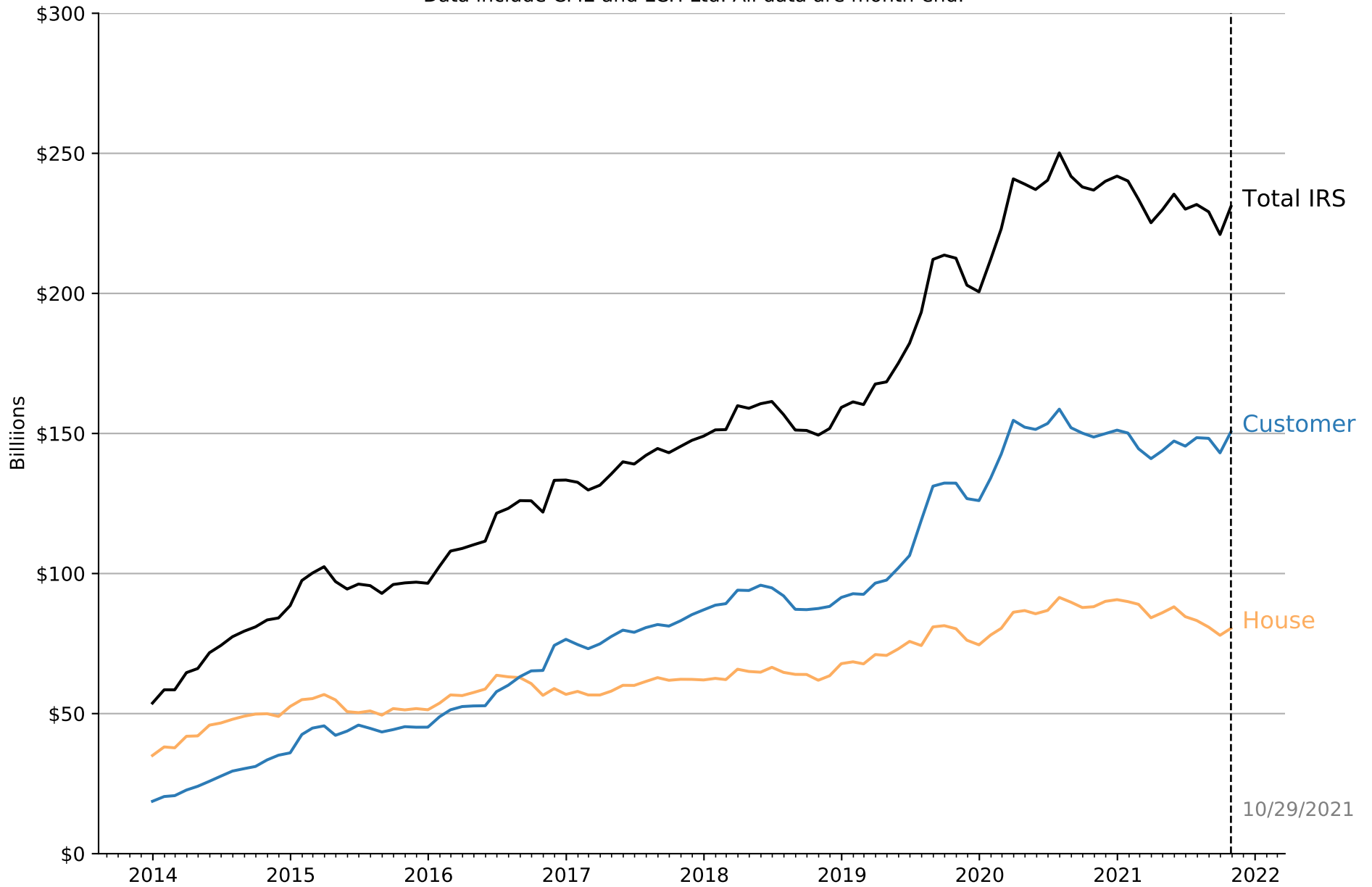
Initial Margin Requirements - Futures

Data include CME, ICEU, and ICUS. All data are month-end.



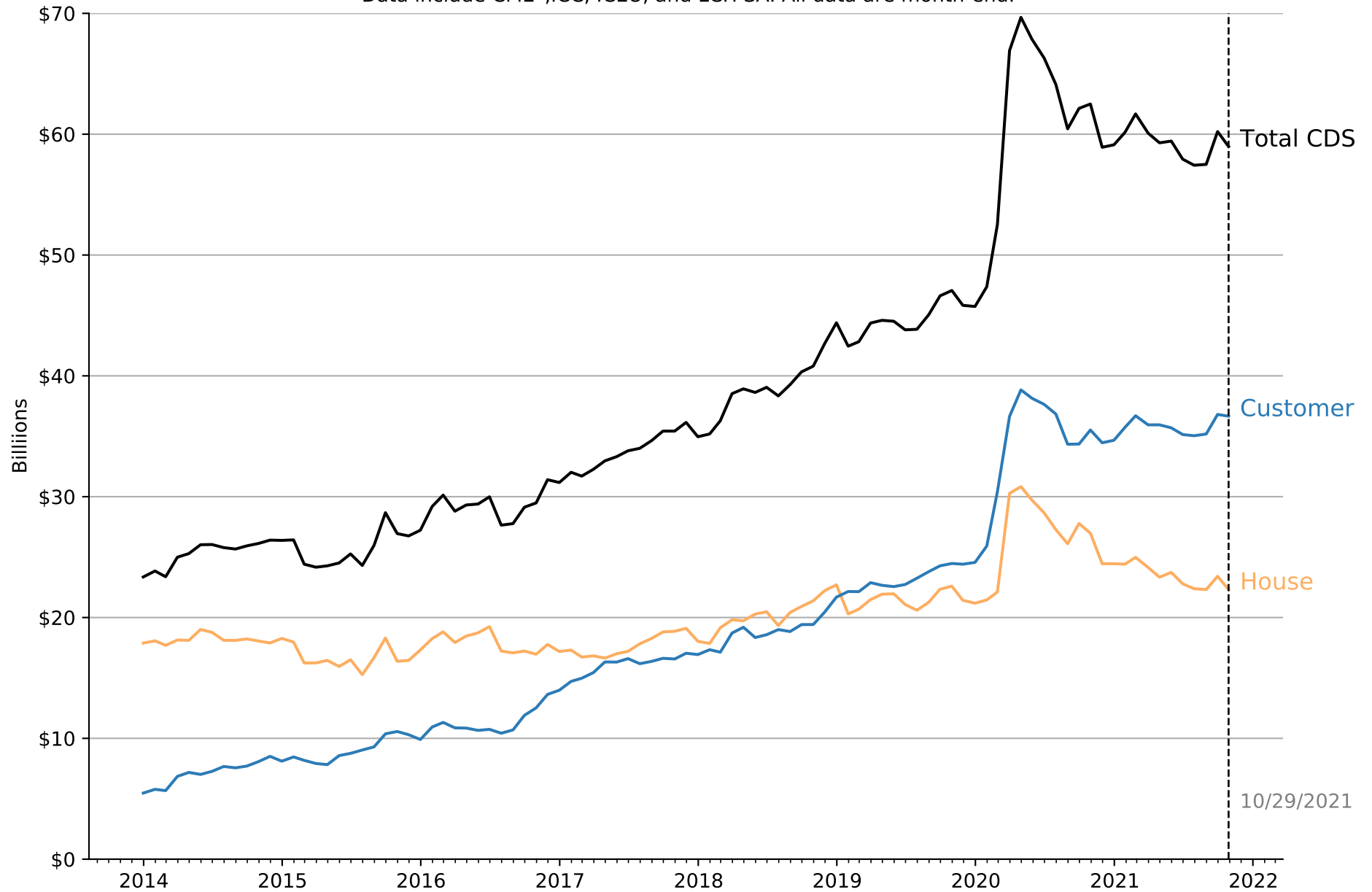
Initial Margin Requirements - IRS

Data include CME and LCH Ltd. All data are month-end.



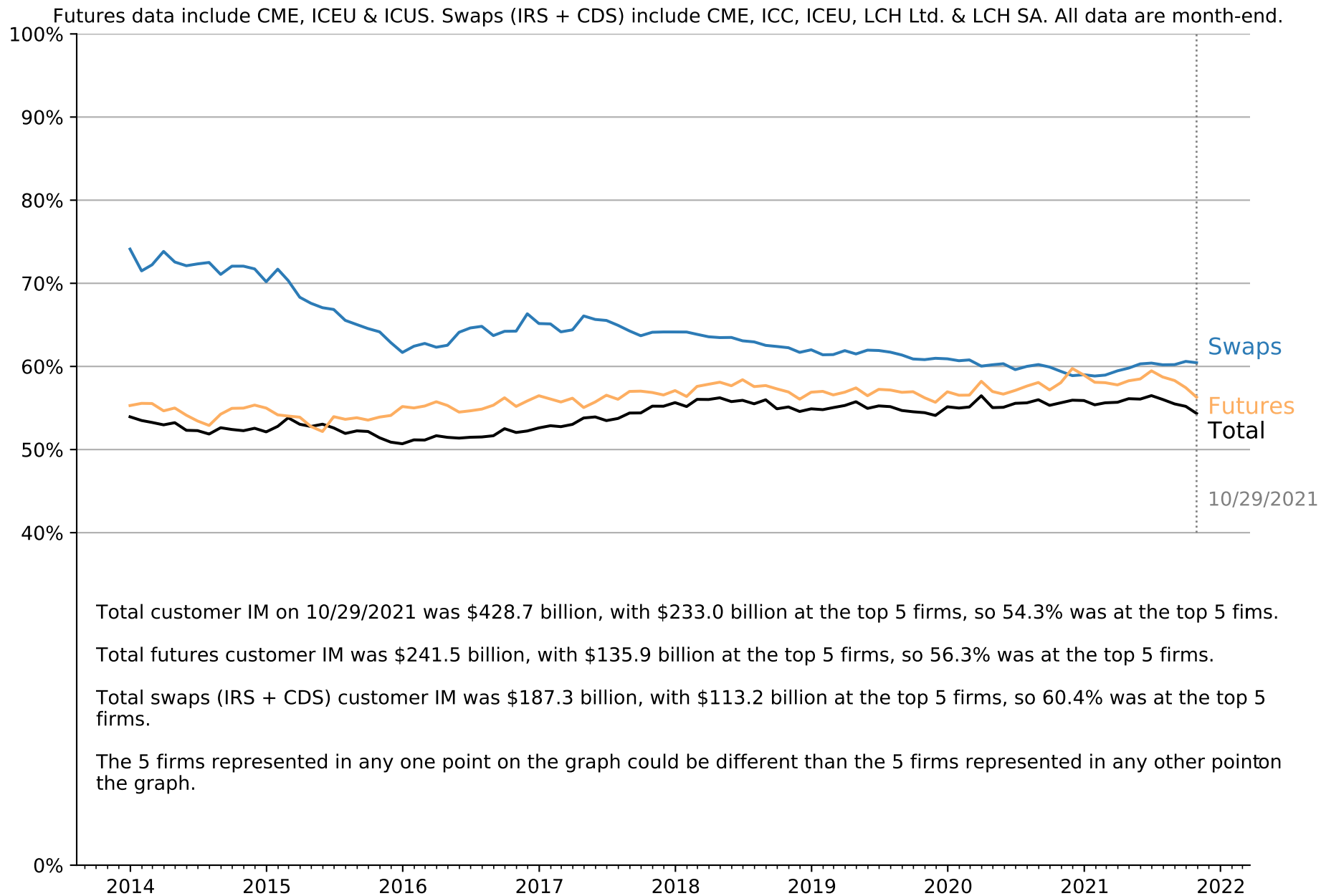
Initial Margin Requirements - CDS

Customer Initial Margin Requirements -Percentage at 5 Largest Parent Firms*



Total customer IM on 10/29/2021 was \$428.7 billion, with \$233.0 billion at the top 5 firms, so 54.3% was at the top 5 firms.

Total futures customer IM was \$241.5 billion, with \$135.9 billion at the top 5 firms, so 56.3% was at the top 5 firms.

Total swaps (IRS + CDS) customer IM was \$187.3 billion, with \$113.2 billion at the top 5 firms, so 60.4% was at the top 5 firms.

The 5 firms represented in any one point on the graph could be different than the 5 firms represented in any other point on the graph.

*Affiliated clearing members are combined into a single parent firm.
