Attached is a list of guests who attended this meeting.

The meeting was called to order at 1:45pm.

Jack Frymire:

Gave opening remarks

Noted that the CBOT received several letters regarding the delivery system

Noted that the task force was recently formed, has had just one meeting, and the only decision was to have the current meeting with industry representatives

Noted the purpose of this meeting was to have an open dialogue

Jim Sutter - Cargill:

Asked how task force put together

Asked how number of members determined - why not an odd number in case of a vote?

Noted we need representatives from processors

Asked why there were two members "from" Iowa Grain

Jack Frymire:

Said he formed the soyoil task force in the same manner the wheat task force was formed

Wanted a task force with non-commercial participants

Noted that if every commercial firm is represented on the task force, you would be unlikely conclusion

Noted the two members "from" Iowa Grain are unbiased - not in soybean oil business

Dave Seagren:

Stated he is a member who was on the committee that formed the contract several years ago was formerly with Cargill and Continental. When the contract was first constructed, everybody participated in setting up the differentials. All were arbitrary to be adjusted by number of deliveries. The automatic adjustment mechanism was developed because, at that time it took 18 to 24 months to approve contract changes.

John Harding: SLS

Noted that now it takes approximately 4 to 6 months to get approval from CFTC for a contract change

Ron Cumer - Central Soya:

Was opposed to the automatic adjustment mechanism. This mechanism reflects different corporate philosophies rather than economics. The current problem with the delivery mechanism is that western oil won't go away, causing the spreads to be unresponsive to basis changes.

*Group has discussed Fast Track 30 Day approval*

George Hoover - Ag Processors (on phone):

Asked what the issues are that created the need for this meeting

Jack Frymire

Letters from the industry

Noted that the NW territory differentials do not line up with the cash market

SASP recent cash market does not favor deliverer

Ken Robinson - ADM:

Noted that the contract performance is generally good, but that the contract has become a substitute for the cash market

Noted that 9% of all oil produced is deliverable on the futures contract

Feels that the futures contract should be a tool for risk management

Note that if the CBOT wants to become a cash market, we need a transportation committee to set differentials B they need to be better reflective of cash market transportation differentials

Notes that you can get delivery in an out-of-location place, but then can not get it shipped to where you need the oil

Load-out is also too slow as it can take three months to get the oil taken on delivery

Noted that there have been 100 point swings in basis with no change in spreads

Suggested limiting deliveries by location, and require loadout in one month

The delivery mechanism is good, but does not change fast enough. The Task Force might consider doubling the maximum amount of the annual adjustment from 10 points to 20 points.

Tom Kersting - South Dakota Soybean Processors:

Asked how quickly loadout should occur

Jim Sutter:

Cargill likes the automatic adjustment mechanism

Adjustment could be faster - bi-annual perhaps

Notes that the NW territory is too large - some sites are mis-valued

Might consider subdividing the NW territory

There is too much concentration of capacity in the NW territory

Notes that it can take several months to get oil out of delivery warehouses

Suggests that loadout speed be tied to capacity

Brent Cohen - on task force:

Asked staff to review of how we got to where we got where we are

Dave Lehman:

Gave a brief review of the process for changing regular firms and rules for loadout

Requirements for loadout and regularity

Noted that if a facility meets all requirements for regularity, historically the exchange has approved the facility

George Hoover:

Noted one location in the NW territory has a disproportionate number of receipts outstanding

Said this is a problem because this location can influence what will happen to the premium/discount of that territory

Need to separate out a portion of the territory

Need to limit the amount of time for loadout

In NW Region AEP has greatest share; ADM is behind SASP

Paul Krug - ADM Investor Services:

Took exception to how we approve new delivery capacity  
Said if we don't need more capacity, we should not register new capacity  
Thinks the CBOT can refuse regular capacity if it will hurt the efficacy of futures trading  
He also served on the automatic adjustment committee B said it has worked well  
But thinks it is now time to review how the adjustment mechanism works  
Is not sure he would favor a bi-annual adjustment but maybe a bigger adjustment once a year

Gene Brvant - ABN Amro:

Asked if the CFTC has ever questioned the deliverable supplies of soybean oil

John Harding: *St. St.*

Noted that in general the CFTC wants to increase deliverable supply  
Also agreed that with oil a tremendous amount of oil is deliverable  
And that the CFTC has never questioned there being too much deliverable supply of oil

Ken Robinson:

Noted that basis can change, but not spreads  
Asked if anything regarding basis change can trigger a CBOT study

Steve Strong - Garmac Grain:

Asked what CFTC's comment would be if we propose a change

John Harding:

Noted that the CFTC would have comments and they would likely have a public comment period  
Noted that the CFTC is trying to determine quantitative estimates of adequate deliverable supply  
The CFTC decided that adequate deliverable supply is 4 times the spot month speculative position limit  
We claimed that the "4 times number" was arbitrary - this issue came up in the IWDS for corn and beans  
Noted that we would have no problem meeting this standard with oil with a much smaller delivery territory

A member asked how long the current system has been in place

Dave Lehman:

Since the late 1980s

Ron Cumer:

Suggested we look at doing a one-time change for delivery locational differentials

John Harding:

Noted it is hard to change on existing contracts

Kevin McClellan: *St. St.*

Noted that a change in differentials (that departed from promulgated formula) would have to be for newly listed contracts. The Exchange can not change a contract in the "middle of the game."

22222:

Noted that we need to do "major surgery"  
What we have no longer works

?????

Noted that the Jan. 2000 oil contract is not yet listed and that the soybean 2000 contract reflects the new delivery system

Suggested we rework the oil contract and make the changes effective with the Jan. 2000 delivery

Jack Frymire:

Asked if speeding up the automatic adjustment mechanism would address the industry's concerns

Paul Krug:

Need to review guidelines on loadout. Minimum truck load-out rate is slower than for rail cars

Dave Lehman:

Noted a swing in the Illinois basis

Asked if the same happened in the NW territory

Also inquired about cash price data in the NW territory

Elinn Maxwell - Delta Commodities:

Noted that the Iowa basis did swing by the same amount as Illinois basis

Paul Krug:

Noted that another issue is rail service (w.r.t. Volga SD). The Exchange might want to consider requiring a price adjustment if the delivery facility is on a short line railroad

Steve Strong-Garnac Grain:

Asked if the CBOT has received any letters suggesting that we don't change anything

Dave Lehman:

No

Jim Sutter:

Noted there are 10 plants in Illinois Territory, some which are far apart

15 plants in NW Territory

Asked why we don't have more differentials

John Harding: *STSS*

Noted that if we have widespread industry support, it would make an attempt to change the differentials and go forward easier to accomplish

Mike Pacelli:

Noted that if we have more territories and the same mechanism, things would work better

We especially need to break up the NW Territory

Jeff Smith (Nidera) on phone:

Gave the "International perspective"

Said there must be change

Noted the futures market does not reflect international values

Noted that a huge volume of oil is traded on a flat price basis

But if the futures market reflects the international cash market, they can hedge better

Steve O'Brien:

Noted that in the last 10 years, there has been a movement of deliveries to NW Territory *Only last 2 years*  
Noted that just because there is high volume does not mean it is a good contract  
Noted that when OI was 175,000, 75,000 of it was from specs - but said spec business is good for a contract  
Regarding differentials, made reference to a "reverse telescope" - if the differential moves 10 points in a year, allow it to go to 15 the next year  
Regarding loadout, we need to get it quicker. Suggested it be based on inventory - i.e. if 500 cars in inventory, require loadout of 50 cars per day  
Regarding Volga, SD, need to look at transportation logistics as well

Ron Cumer:

Thinks even if the automatic adjustment mechanism is speeded up it will take too long to get Volga in line with the cash market

Steve O'Brien:

Noted we have a problem at Volga  
We must solve it  
We must never let it happen again  
From Jan. 2000 forward, we need a change  
Get Volga at 70 under  
We made a mistake letting Volga come on

Jack Frimire: - *Chairman Task Force*  
Agrees with Steve O'Brien

?????

Asked how long Volga has been regular

Fred Clark:

Since April 1996

?????

Asked about the time line for solving the problem

Consensus:

ASAP - *Not all agree in room*

Kevin McClear:

Was unaware of the CBOT turning down anyone for regularity who met the requirements, moreover if an applicant's inclusion in the system would negatively impact the contract CBOT would consider denying the application for regularity.

Rav Czupek:

Noted that we turned down firms for regularity back in the 70s  
Noted over the past 5 years we have had a preponderance of deliveries in the NW Territory *Again 2 years*  
Suggested we question whether non-crushing facilities should be regular

Paul Krug:

Noted that the Cargill Burns Harbor facility was turned down initially as a regular grain warehouse

Tom Kersting - SD Soybean Processors:

Noted the cash market has changed and the spreads are no longer at full carry

SD Soybean Processors has canceled regularity at their St. Paul facility

Noted the cash values have risen so Volga is not deliverable - Delivery is no longer the best market for  
Volga

Jack Fromire:

Thanked everyone for coming and for providing input. Suggested that people schedule appearances before  
the Task Force individually or submit comments in writing

## SOYBEAN OIL

### INTRODUCTION

The soybean oil futures contract is a successful contract. Even though volume and open-interest are up, concerns have been expressed on the relationship of soybean oil delivery differentials to cash market differentials for selected territories and the preponderance of deliveries from the Northwest Territory that includes the location of Volga, South Dakota. Soybean oil futures trading volume and open-interest, the number of outstanding soybean oil receipts by territory, the automatic adjustment feature for determining territorial delivery differentials, and regular storage capacity are reviewed to determine if the current data observed is notably different from past data observed. A difference would suggest that further review of the contract is warranted.

### VOLUME AND OPEN-INTEREST

As shown in Table 1, futures trading volume in the CBOT soybean complex for 1997 was more than twenty-six million contracts as compared to a low of more than twelve million contracts in 1986. Individual commodity trading volumes in the soybean complex for 1997 were approximately 14.5 million contracts of soybeans, 6.5 million contracts of soybean meal and five million contracts of soybean oil with market shares of 55%, 24%, and 20%, respectively. Yearly trading volumes of soybeans, soybean meal and soybean oil from 1980 to present are shown in Chart 1.

Trading volume in the soybean complex for the first 8 months of 1998 has shown an increase for soybean oil, a decrease for soybeans and a slight increase for soybean meal. In the first 8 months of 1998, soybeans accounted for 48% of the total trading volume in the soybean complex compared with a 25% share for soybean meal and a 26% share for soybean oil. While the shift in the market shares of trading volume in the soybean complex for soybeans and soybean oil from 1997 to the first eight months of 1998 was significant, the relative market shares in the first eight months of 1998 for all three commodities are similar to their respective market shares in both 1986 and 1987. For these two years, soybeans accounted for 49% of the trading in the soybean complex, soybean meal 24% and soybean oil 26%.

Open-interest for the soybean complex at the end of August of 1998 was 397,511 contracts, up approximately 50,000 contracts from open-interest recorded at the end of 1997. While open-interest in all three commodities increased from 1997, there was a shift in the relative shares of open-interest among the three commodities. The relative share of open-interest for soybeans declined to a 37% share while soybean meal increased to a 35% share of total open-interest in the soya complex. Soybean oil with an open-interest of 111,950 contracts at the end of August of 1998 accounted for a 28% share which is typical share based upon end-of-the-year open-interest since 1980.

## TERRITORIAL DIFFERENTIALS

Based upon volume and open-interest, the soybean oil futures contract has been successful over the years. However, given this success, questions have always been raised on the appropriate delivery differentials, when a predominance of deliveries has come from one delivery territory or warehouse.

As shown in the attached map, the soybean oil delivery area is divided into 5 delivery territories, Illinois, Eastern, Southwest, Eastern Iowa and Northwest. The relative and absolute amount of oil represented by outstanding receipts among the five delivery territories has varied over time. As shown in Chart 2, the Eastern territory, with more than a 70% share, was the dominant issuer of outstanding receipts in the 1989/90 marketing year. By the 1994/95 marketing year, Illinois was the dominant territory with more than 60% share of the outstanding receipts and the Eastern territory fell to last place with less than a 5% share of outstanding receipts. In 1995/96, Eastern Iowa became the dominant territory with more than 45% of total outstanding receipts, followed by the Southwest territory with an approximate share of 25%. For the 1996/97 marketing year, the combined outstanding receipts issued by the Eastern Iowa territory and Southwest territory decreased to approximately 35% with the Northwest territory share increasing to approximately 25% of the total outstanding receipts. For the 1997/98 marketing year, the Northwest share of outstanding receipts increased to 55% of the total with the Southwest share declining to 3%.

The reason that no one delivery territory has been dominant over the nine-year time span is the automatic adjustment mechanism to determine delivery differentials for soybean oil. This mechanism compares the ratio of outstanding receipts to production capacity in one territory relative to the ratio of outstanding receipts to production capacity in all other territories. For a marketing year, if the average ratio is .2 or above (.5 or lower), that territorial differential is adjusted downward (upward) 5 cents per hundredweight. The theory is that any territory with twice (half) as many receipts outstanding to all other territories is overpriced (underpriced). The weekly average outstanding receipts, cumulative average automatic adjustment ratios and the territorial delivery differentials since the system was adopted are shown in Table 2. Production capacity is proprietary information and is not shown.

A comparison of yearly territorial delivery differentials (Table 2) with the relative percentage share of year average weekly outstanding soybean oil receipts (Chart 2) shows that the mechanism has caused the relative share of outstanding receipts to level out across the various delivery territories over time. For the first four years of adjustments, increasing discounts in the east coupled with decreasing discounts in the west changed the distribution of outstanding receipts by reducing the share of receipts issued by the Eastern territory. For the 1993/94 and 1994/95 marketing year, the large relative share of receipts issued by the Illinois territory caused discounts at all other territories to lessen or remain the same with a corresponding increased share of outstanding certificates from these territories. For the 1995/96 and 1996/97 marketing years the smaller share of receipts issued by the Illinois territory caused discounts to increase or remain the same in all other territories.

For the 1997/98 marketing year, the Northwest territory share of receipts was approximately 55 percent and accumulative ratio at the end of the marketing year was 2.2. This ratio of 2.2 for the Northwest territory compares with a .6 ratio for Illinois, .8 for Eastern, 1.2 for Eastern Iowa, and .2 for the Southwest. These ratios will cause the 1999 differential for the Northwest territory to widen to -25 cents per hundredweight and the Southwest differential to narrow to -15 cents per hundredweight. The differentials for all other territories remained the same.

Charts 3 and 4 show the absolute number of outstanding receipts for all territories and each territory by year and by week, respectively. The yearly average of weekly outstanding certificates for all territories has ranged from more than 7,000 receipts in the 1992/93 marketing year to less than 200 receipts in the 1994/95 marketing year. Outstanding receipts by week have gone from a high of more than 10,000 in the summer of 1992 to zero in summer of 1995 and back up to more than 8,000 outstanding receipts in summer of 1997. Since the summer of 1997, outstanding receipts have fallen below 6,000. The total number of outstanding receipts can change quickly based upon market conditions. Receipts can be issued and delivered by shorts when there is a surplus of oil and be canceled and loaded-out by longs when supplies begin to tighten.

The automatic adjustment feature should not affect the total number of receipts issued by all territories but should affect the distribution of outstanding receipts by territory. The data suggests that the automatic adjustment feature is accomplishing its objective of equalizing deliveries among territories. The mechanism provides an objective and gradual way to adjust delivery differentials. While the mechanism has been criticized as being too slow (5 to 10 cents per hundredweight per year) in causing the necessary adjustments to a territory, an increase in the magnitude of the yearly adjustment would increase the costs to holders of receipts of the affected territory. The maximum lost to a holder of a receipt of an affected territory is \$ 60 per contract.

### REGULAR CAPACITY

Soybean oil deliveries are by warehouse receipts that represents crude soybean oil in-store at shippers' storage tanks declared regular for delivery. Regular capacity is granted by storage tank with the shipper's choice of registering from 1 to all his tanks. The shipper may own his storage facilities or lease tanks for storing vegetable oils in a commercial tank farm.

The regular capacity for the delivery of soybean oil as shown in table 3 has fluctuated since 1980. In five-year periods from 1980, capacity increased by approximately 10,000 warehouse receipts each five-year period to a high of over 31,000 receipts in 1990. In the next five-year period, capacity decreased by 10,000 certificates to slightly over 21,000 receipts in 1995. From a low of 20,552 warehouse receipts in 1996, current deliverable capacity as of June 30, 1998 is 27,262 receipts. This current regular capacity of 27,241 warehouse receipts (1,634,460,000 lbs.) is neither a high nor low amount of declared regular capacity.

## CONCLUSION

The current number of outstanding soybean oil warehouse receipts, the relative shares of receipts by territory and the amount of regular capacity are not unusually large or small compared to past data observed. A review of the data shows that the automatic adjustment feature of the contract is working by leveling out the amount of outstanding receipts across the delivery territories. Given the current level of the cumulative territorial delivery differentials against threshold values for the automatic adjustment mechanism, additional adjustments for next year could be possible that would increase the delivery discount in the Northwest territory.

Based upon volume and open-interest, the soybean oil contract has been very successful and is continuing to be successful. The increase of soybean oil open-interest to a share held by soybeans in the soybean complex is a positive difference for the soybean oil contract.

In summary, a review of the above data does not show a problem with soybean oil deliveries or the contract itself.

Yet the back force continues
