

NYMEX EUROPE ADDENDUM TO MEMBERSHIP APPLICATION

I (and/or my company as applicable) hereby apply for the NYMEX Europe Permit being made available by the New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange"). If I (and/or my company as applicable) am /is approved by NYMEX for this permit, I (and/or my company as applicable) agree(s) to abide by and to be subject to the Bylaws and Rules of NYMEX as they now exist and to any amendments which may be made thereto in the future.

I (and/or my company as applicable) acknowledge, agree and consent that as a NYMEX Europe Permit Holder, I (and/or my company as applicable) and my (our) respective employees and agents shall be subject to the Exchange's disciplinary jurisdiction and proceedings in the same manner as a Member, agent or employee, as applicable. Accordingly, for example and as provided by applicable Exchange rules, I (and/or my company as applicable) shall be responsible for, and subject to disciplinary action as a result of, the acts or omissions and for the breaches or violations of Bylaws and rules of employees.

I (and/or my company as applicable) further acknowledge, agree and consent that, as an ongoing condition of participation as a NYMEX Europe Permit Holder, I (and/or my company as applicable) will be bound by the U.S. Commodity Exchange Act and by Commodity Futures Trading Commission regulations as applicable; I (and/or my company as applicable) will provide access to the Exchange, to the Commodity Futures Trading Commission and to the U.S. Department of Justice of all relevant books and records; and I (and/or the company) applying for this permit as applicable irrevocably submit to the in personam jurisdiction of State and Federal courts and administrative courts located in the City and State of New York.

I (and/or my company as applicable) acknowledge that failure to comply fully with any of the ongoing conditions of participation in the permit program stated above could result in immediate suspension and/or termination of this permit and could additionally result in further disciplinary action as appropriate.

Finally, I (and/or my company as applicable) acknowledge and confirm that I (and/or my company as applicable) will inform every employee and agent who engages in conduct on the Dublin trading floor on my behalf (and/or my company as applicable) relating to the offer, purchase, sale, or holding of Exchange contracts or the exercise of my (and/or company's as applicable) trading privileges that the foregoing acknowledgements and agreements shall also apply to them. I (and/or my company as applicable) will also undertake to secure every such employee or agent's written consent to the application of all of the preceding paragraphs listed above.

If any provisions of this permit application is held by a court of competent jurisdiction to be contrary to law, the remaining provisions of this application will remain in full force and effect.

Nothing in this agreement shall limit the powers of the Central Bank and Financial Services Authority of Ireland and/or the

Irish Financial Services Regulatory Authority or the application of Chapter VIII of the Central Bank Act, 1989 and the Central Bank Act, 1942 (as amended)¹ of Ireland, in relation to the Dublin trading floor.
