Order Vacating Default Order Dated March 26, 2010

Five months have passed since the National Futures Association provided the CFTC with definitive confirmation of Michael Chen's death by apparent suicide after he had absconded with funds fraudulently debited from the accounts of several customers, including Hsui Chu Liang. This has provided ample time for any estate to file an appearance, to explain the disposition of the converted funds, to reach an accommodation with Liang, or to file a motion to vacate the default order. No such estate has appeared. A recent search by my office has not discovered any estate for Chen.

In these circumstances, the prospect of recovery of the fraudulently converted funds is presumably highly remote, and *sua sponte* vacation of the Default Order and dismissal of the complaint against Chen is warranted. Accordingly, the Default Order dated March 26, 2010 is hereby vacated, and the complaint against Michael Chen is hereby dismissed.²

Hi Patrick.

We didn't receive any official documentation confirming Chen's death. We initially found out about it from Kip Delbridge at FCStone. Kip had called NFA because they had been notified by one (or some) of GMC's customers that Chen had died and that it appeared that there had been some unauthorized withdrawals from her/their account(s). In the end, it appeared that Chen was requesting withdrawals from non-discretionary IB customer accounts and receiving these checks directly from FCStone. Due to GMC's customers being Chinese and that they were generally local, they would then come into GMC's offices to pick up these checks. What was really happening was that Chen was signing the checks over to himself and depositing them into his own bank account.

At the beginning of the investigation we spoke with two employees of GMC, Weiliang Shao and Hannah Hua, who confirmed Chen's death. We also located an online article for a local newspaper regarding the accident which identified Michael Chen, age 55 and resident of Rowland Heights, CA which matched Chen's information on file at NFA.

Man walks into traffic, is killed

ONTARIO - A man was killed when he walked into oncoming traffic Monday on the 60 Freeway, police officials said.

Michael Chen, a 55-year-old resident of Rowland Heights, was struck by a semi-truck in the freeway's eastbound lanes. He was pronounced dead at the scene at 12:17 p.m.

The man was walking the lanes near the Haven entrance of the freeway around 12:11 p.m. when he walked in front of traffic, said Ontario police Lt. John Evans.

In the accident, the car, trying to avoid the pedestrian, collided with another vehicle.

Several freeway lanes were closed for more than an hour while police investigated the accident.

The Ontario Police Department and the San Bernardino County Coroner's Office is investigating the accident.
