LETTER TO THE JUDGE


Dear Judge Levine,

LETTER TO THE JUDGE

JUDGE LAVINE, WE WOULD HAVE LOVED TO BRING ALICE WELTON BACK IN BUT THINGS HERE IS NO BETTER. MY DAD HAS HAD 3 SURGERIES IN THE PAST 18 MTHS AND HIS DEPRESSION IS WORSE. THE DOCTOR HAS HIM ON A HEAVY DOSS OF DEPRESSION MED(TWICE AS MUCH AS BEFORE). NOW ALSO I WILL HAVE A BABY IN LATE JUNE AND I NEED TO WATCH MY STRESS LEVEL FOR THE BABY HEALTH AND MINE. I STILL FEEL THE SAME ABOUT ALICE WELTON AND WHAT SHE DID WITH SOUTHCOAST COMMODITIES WAS WRONG AND ONE DAY SHE WILL GET WHAT SHE DESERVE. SO I DON'T WANT TO BRING HER BACK IN THE CASE CAUSE IT IS NOT WORTH IT CAUSE I'VE TRIED MANY YEARS TO HAVE THIS BABY AND I DON'T WANT TO RISK ANYTHING. I THINK YA'LL WILL UNDERSTAND.

IF I UNDERSTAND WHAT YOU SENT MEANS A JUDGEMENT WILL BE. AGAINST THE OTHER PARTIES THAT ORDERED THEY WERE IN DEFAULT. SO I WANT TO KNOW WILL THE JUDGEMENT BE ORDERED AND WHAT DO YOU DO WHEN A DEFAULT JUDGEMENT IS ENTERED. CAN YOU TELL ME CAUSE RIGHT NOW I CAN'T ASK DAD TO HELP ME DO THIS CAUSE OF HIS HEALTH. HE IS SO ANGRY AT THESE PEOPLE FOR WHAT THEY DID TO US. WHEN WE RECEIVED YOUR PACKAGE IN THE MAIL IT BROUGHT BACK EVERYTHING TO HIM.

SO IF THE DEFAULT JUDGEMENT WILL STAND LET ME KNOW .IF I HAVE TO DO A LOT OF STUFF TO GET THE JUDGEMENT THEN WE WILL FORGET IT AND THEY WILL GET AWAY WITH IT. I KNOW MY DAD AND I PUT IN MANY HOURS OF WORK TRYING TO DO WHAT YOU SAID NEEDED TO BE DONE. THEY (DEFENDENTS) DID NOTHING AND THEY THINK NOTHING WILL HAPPEN TO DO AND I HOPE ITS WRONG. SO PLEASE LET ME KNOW WHAT YOU ARE GOING TO THEM. IF NOT I DO NOT WANT TO RISK MY BABY I'M CARRYING AND MY DADS HEALTH.
