To Whom it May Concern:

Pursuant to Section 5h of the Commodity Exchange Act and Part 37 of the regulations of the Commodity Futures Trading Commission (“CFTC”), INFX SEF, Inc. (“INFX SEF”) hereby submits this Swap Execution Facility Application. INFX SEF respectfully requests that the CFTC grant INFX SEF’s application for temporary registration pursuant to CFTC regulation § 37.3(c). INFX SEF requests from the CFTC a unique, extensible, alphanumeric code for the purpose of identifying the SEF pursuant to Part 45 of the CFTC’s regulations.

INFX SEF has submitted to the Assistant Secretary of the Commission for Freedom of Information a request for confidential treatment of the documents listed on Schedule I hereto. INFX SEF requests confidential treatment for these materials pursuant to CFTC regulation § 145.9(d)(1)(ii) because disclosure of such materials would reveal trade secrets and/or confidential commercial or financial information of INFX SEF. We request this confidential treatment for an indefinite period.
