
Dear CFTC Commissioners:

The New York Mercantile Exchange, Inc. ("NYMEX" or the "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") of an amendment to Supplement No. 2, "Licensed Depositories and Weighmasters for Gold", Supplement No. 2 "Licensed Depositories and Weighmasters for Silver", Supplement No. 1 "Official List of Approved Depositories for Platinum", and Supplement No. 1 "Official List of Approved Depositories for Palladium" to be implemented effective Friday, August 3, 2007. The amendment delists the ScotiaMocatta 26 Broadway Depository facility as an Exchange Licensed Depository for Gold, Silver, Platinum, and Palladium. As of June 1, 2007, all material that had been stored in this facility has been relocated and it is no longer used as a depository.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendment complies with the Act, including regulations under the Act. This amendment will go into effect on Friday, August 3, 2007.
