Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended, and Commission Regulation 40.6, ICE Futures U.S., Inc. ("Exchange") submits, by written certification, an amendment to Pulp Appendix I, attached as Exhibit A.

The amendment to Pulp appendix I adds another brand of NBSK pulp that would constitute good delivery for an Exchange pulp futures contract.

The Exchange certifies that the amendment complies with the requirements of the Commodity Exchange Act and the rules and regulations promulgated thereunder. No substantive opposing views were expressed by members or others with respect to the amendment. The amendment was adopted by the Exchange's Board of Directors on November 14, 2007 and will become effective on Wednesday, November 21, 2007.
