Pursuant to Section 21 of the Commodity Exchange Act and Part 49 of the regulations of the Commission, BSDR LLC (the "<u>Applicant</u>"), as proposed operator of a swap data repository, submitted to the Commission a third amended Swap Data Repository Application for Registration on Form SDR dated August 2, 2013 (together with each exhibit thereto, the "<u>Third Amended Application</u>").

On August 12, 2013, the staff of the Commission provided the Applicant with certain questions with respect to Applicant's ability to accept and report swap data as set forth in Part 43, Part 45, Part 46 and Part 50 of the Commission's Rules (the "Staff Questions"). As requested by the staff of the Commission, the Revised Staff Questions Responses, the SDR Checklist and the Fourth Amended Application consist in part of blackline comparisons showing portions of the Fourth Amended Application marked against corresponding portions of the Third Amended Application.

The Applicant hereby requests that the Confidential Information (as defined below) be accorded confidential treatment on the grounds that it would reveal the Applicant's trade secrets and confidential commercial or financial information.
