I also own the rights to the cartoon character, SQRAT, is a popular character of the international hit Ice Age, Ice Age 2, Ice 3 and the upcoming Ice Age 4.An arbitrator decided that both Fox and I own the copyright to the character.

Domestic Box Office Futures (DBOR) have a real economic value to me.

As a cartoon licenser, DBOR will provide a more reliable way to measure the value of box office receipts. Traditionally, film studios have employed murky methods. DBOR will help me better value the worth of my licensing rights.
