Re: Rule Certification. NYMEX Submission 08.19: Notification of Amendments to NYMEX Rules 9.26, 9.27, 9.34 and Exchange Rule 11.63 for the NYMEX Colombian Peso Futures Contract.

Dear Mr. David Stawick:

The New York Mercantile Exchange ("NYMEX" or the "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") of amendments to NYMEX Rules 9.26, All Month/Any One Month Accountability Levels, 9.27, Expiration Month Limit, 9.34, Reporting Levels, and Exchange Rule 11.63, Electronic Trading Error Trade Procedures.

Effective for trade date February 25, 2008, these amendments include the addition of accountability levels, position limits, and reportable levels for the new NYMEX Colombian Peso Futures Contract (see attached Chapter 9, Appendix A). The amendments also fix the "no bust range" at 100 ticks for the new contract. Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that the attached rule amendments comply with the Act, including regulations under the Act.
