REVISED Rule Certification, New York Mercantile Exchange, Inc. Submission #10-020R: Amendment to Listing Date on Globex[®] for Four (4) Vintage Year-Specific Green Futures Products

Dear Mr. Stawick:

By letter dated January 21, 2010 (Submission #10-020), the New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") notified the Commodity Futures Trading Commission ("CFTC" or "Commission") that it was self-certifying amendments to the Regional Greenhouse Gas Initiative (RGGI) CO2 Allowance Futures contract in order to accommodate for the delivery of contracts with four specific vintage years effective January 25, 2010. In addition, the Exchange also notified the Commission that effective March 8, 2010, the four vintage year-specific listings will also be available on Globex trading

In this revised submission, the Exchange is notifying the Commission that the Exchange is amending the Globex listing date for the four vintage year-specific Regional Greenhouse Gas Initiative (RGGI) CO2 Allowance Futures contracts. These contracts will become available on Globex trading venue effective trade date March 22, 2010, on which date, these futures contracts will no longer be available for trading on the NYMEX trading floor. Please note that these contracts will continue to be available for submission for clearing through CME ClearPort.

The remainder of the content of original Submission #10-020 is unchanged. For your convenience, please find below the four vintage year-specific Regional Greenhouse Gas Initiative (RGGI) CO2 Allowance Futures contracts, Globex commodity codes, rule chapter and listed months.
