Re: Rule Certification. New York Mercantile Exchange, Inc. Submission #08.28: Notification of the Delisting of the Brent-Oman Financial Spread Contract (QN), and the WTI-Oman Financial Spread Contract (QW), and related amendments to NYMEX Chapter 9, Appendix A

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or the "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that the NYMEX will no longer clear the following contracts which will be de-listed by the Dubai Mercantile Exchange, effective close of business for trade date March 3, 2008: the Brent-Oman Financial Spread Contract (QN), and the WTI-Oman Financial Spread Contract (QW). To date, these contracts have been commercially unsuccessful and have no open interest. Also effective close of business for trade date March 3, 2008, Chapter 9, Appendix A, of the NYMEX Rulebook will be amended as indicated in the attached to reflect the de-listing of the above mentioned contracts.

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby certifies that this notification complies with the Act, including regulations under the Act.
