Dear Ms. Jurgens:

Chicago Mercantile Exchange ("CME") pursuant to Commodity Futures Trading Commission ("the "Commission") Regulation 39.5 hereby notifies the Commission of the acceptance of CDX North American Investment Grade Index Series 20 ("CDX IG 20") and CDX North American High Yield Index Series 20 ("CDX HY 20") for clearing. CDX IG 20 will be accepted for clearing on March 20, 2013 and CDX HY 20 will be accepted for clearing on March 27, 2013.

Please note that the Exchange is submitting CME Submission NO. 13-071R to include revisions to the original submission to reflect the correct termination date of CDX HY 20. A black-lined version of CME Submission No. 13-071R is attached as Appendix 2, with additions underlined and deletions stricken through.

Pursuant to Regulation 39.5(b)(3)(i), CME states that it is eligible to accept CDX IG 20 and CDX HY 20 for clearing as such swaps are in a group, category type or class of swaps that is already clears. Should the Commission determine that such swaps are required to be cleared, CME will be able to maintain compliance with the DCO core principles set forth in Section 5b(c)(2) of the Commodity Exchange Act (the "Act") and the regulations promulgated thereunder.

This filing supplements our previous submission to the Commission, dated February 22, 2012 (Mandatory Clearing Determination for Pre-Enactment Swaps and Swaps Cleared as of February 1, 2012, CME Submission No. 12-053) which included information for such swaps pursuant to Commission Regulation 39.5(b)(3). The information submitted in Submission No. 12-053 with respect to OTC credit default swaps is incorporated herein. As supplement to Submission No. 12-053, pursuant to Regulation 39.5(b)(3)(iii), the symbols for CDX IG 20 and CDX HY 20 are "CG20" and "CY20" respectively.

The related maturities for each of the above series is set forth in the changes to Appendix 1 to CME Chapter 802 Rules attached hereto.

Additionally, pursuant to Commission Regulation 40.6(a), CME is hereby notifying the Commission of the removal effective immediately from the list of accepted CDX Indices certain CDX North American Investment Grade ("CDX IG") products whose termination dates have passed. These products are set forth in the following table and have been deleted as changes to Appendix 1 to CME Chapter 802 Rules attached hereto:
