Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") of administrative amendments to prior Submission #09-20, dated February 17, 2009, which certified amendments to Chapter 9A, Appendix A in connection with the listing of the new Henry Hub Financial Last Day Option Contract. That submission incorrectly referenced Rule 9A.27, Expiration Month Limits, on the cover letter and in Chapter 9A, Appendix A. Also, Appendix A incorrectly labeled the rule heading as "Expiration Month Limit." The correct rule number is NYMEX Rule 9A.27A, and the correct name of the rule heading is "Expiration Accountability Level Last Day Contracts."

Pursuant to Section 5c(c) of the Commodity Exchange Act ("Act") and CFTC Rule 40.6, the Exchange hereby notifies the CFTC of the attached administrative amendments. These changes will be made effective on trade date March 9, 2009.
