The New York Mercantile Exchange ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying amendments to Exchange Rules 9.26, All Month/Any One Month Accountability Levels, 9.27, Expiration Month Limit, and 9.34, Reporting Levels, in relation to the listing of a new Ethanol Futures Contract. The new Ethanol Futures Contract is being sent under separate cover labeled with submission #08.31. These amendments include the addition of accountability levels, position limits, and reportable levels for the Exchange's new physically-delivered New York Harbor Ethanol Futures Contract.
