RE: Weekly Notification of Rule Amendments: Nadex Adds Strikes in its Daily US Tech 100, Wall St 30, US 2000, Germany 30, Silver, and Gold Binary Contracts for Trade Date April 4, 2012; Nadex Settles its Non-Farm Payrolls Contracts on April 9, 2012- Submission Pursuant to Commission Regulation §40.6(d)(iv)

Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that it has added additional strike levels in its Daily US Tech 100, Wall St 30, US 2000, Germany 30, Silver, and Gold Binary Contracts on a discretionary basis for trade date April 4, 2012. Nadex returned to its regular listing schedule for these contracts on April 5, 2012. New strikes created on trade date April 4, 2012 are set forth in Exhibit A.

Additionally, due to the US Good Friday holiday on April 6, 2012, Nadex settled its Non-Farm Payrolls Binary Contracts on Monday, April 9, 2012, rather than Friday, April 6, 2012, as the Exchange was closed for the holiday.
