Chicago Mercantile Exchange Inc. ("CME" or "Exchange") hereby notifies the Commission that the Exchange has approved amendments to CME Rule 588.K to amend the no bust ranges for NYMEX Crude Oil and NYMEX miNY Crude Oil, NYMEX Brent and NYMEX REBCO. Additionally, the no bust ranges for COMEX London Primary Aluminum, COMEX London Copper Grade A and COMEX London SHG Zinc were removed from the list. The rule changes are attached with the additions underlined and deletions lined out.

The changes will be effective for trading on Sunday, May 11, 2008.

CME certifies that these changes neither violate nor are inconsistent with any provision of the Commodity Exchange Act or of the rules and regulations thereunder.
