2011.00. HOURS OF TRADING.

Pursuant to the provisions of **Rule 210.01.**, the Board of Directors has adopted this Regulation.

The hours of trading at the Minneapolis Grain Exchange shall conform to Central Time.

B. SPRING WHEAT CONTRACT

1. The hours of trading in Spring Wheat Futures on MGEXpress® shall be from six o'clock (6:00) p.m. to ~~six-seven-fifteen~~ o'clock (~~7~~6:15~~00~~) a.m. and from nine-thirty o'clock (9:30) a.m. to one-thirty o'clock (1:30) p.m.
2. The hours of trading in Spring Wheat Options by open outcry shall be from nine-thirty o'clock (9:30) a.m. to one-thirty o'clock (1:30) p.m.
3. The hours of trading in Spring Wheat Options on MGEXpress® shall be from six o'clock (6:00) p.m. to ~~six-seven-fifteen~~ o'clock (~~6~~7:00~~15~~) a.m. and from nine-thirty o'clock (9:30) a.m. to one-thirty o'clock (1:30) p.m.
