Ladies and Gentlemen:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and Section 40.6 of the regulations promulgated by the Commodity Futures Trading Commission ("Commission") under the Act, the NASDAQ OMX Futures Exchange, Inc. ("NFX" or "Exchange") submits this self-certification to amend its trading calendar for the remainder of 2012 and for 2013 to specify the days and hours the Exchange will be closed for business. This amendment will be effective on July 27, 2012.

NFX posts its days and hours of trading on its website for its currency futures as per NFX Rule E4. In addition, NFX has specified in Rule 2001B that the trading hours for XAU/USD Spot Gold futures shall be from 8:00 a.m. to 5:00 p.m. E.T. The Exchange will amend the trading hours and days for all Exchange listed products as specified in Exhibit A. The Exchange will post these amendments to the trading calendar for 2012 and 2013 on its website on July 27, 2012 to provide notice to its members and member organizations of the revised trading calendar.

There were no opposing views among NFX's Board of Directors, members or market participants. NFX hereby certifies that the amendments to its trading hours and days complies with the Commodity Exchange Act and regulations thereunder. The Exchange also certifies that a notice of pending certification with the Commission and a copy of this submission have been concurrently posted on the Exchange's website.
