RE: Weekly Notification of Rule Changes: Nadex Adds Strikes on a Discretionary Basis in its US 500, US Tech 100, and Wall Street 30 Daily Binary Contracts for Trade Date Friday, August 5, 2011 Only - Submission Pursuant to Commission Regulation §40.6(c)(iv) (Final Commission Rule Amendment §40.6(d)(iv), effective September 26, 2011)

Dear Mr. Stawick:

Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section 40.6(c)(iv) of the current regulations<sup>1</sup> promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), North American Derivatives Exchange, Inc. ("Nadex") hereby submits to the Commission its weekly notification of changes for the week commencing August 1, 2011 and ending August 5, 2011. Due to volatility in the underlying US index markets and pursuant to Nadex Rules 12.59(f)(x), 12.63(f)(x), and 12.65(f)(x), Nadex has added twenty-one additional strike levels on a discretionary basis in each of its US 500, US Tech 100, and Wall Street 30 Daily Binary Contracts for trade date Friday, August 5, 2011 only. Nadex currently intends to return to its

regular listing schedule on Monday, August 8, 2011 and will list its regular number of strikes as set forth in Chapter 12 of the Nadex Rulebook. New strikes created for trade date Friday, August 5, 2011 are set forth in Exhibit A.

Nadex hereby certifies that the revision contained herein complies with the Act, as amended, and the Commission Regulations adopted thereunder.
