("CBOT" or "Exchange") hereby notifies the Commodity Futures Trading Commission of an amendment to Chapter 7 in the Interpretations & Special Notices Relating to Chapter 7 section of the CBOT Rulebook. The Exchange has been notified that "Flint Hills Resources Biofuels, LLC," a regular firm for the delivery of Ethanol, has changed its name to "Flint Hills Resources Grain, LLC." The change is a result of an organizational change.
