Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that it is self-certifying the amendment of the contract listing schedule for (6) monthly futures and two (2) options listed below.

Specifically, pursuant to contract rules 893.05, 803.05, 383.03, 859.06, 774.06, 802.06, 774A.05, and 921.06, the Exchange is expanding the listed contract months such that the eight (8) Midwest ISO Cinergy Hub contracts are listed for the balance of the current year and the next five consecutive calendar years with a new calendar year added following the termination of trading in the December contract month of the current year, with the exception of the option on calendar futures strip (chapter 921), which will be listed for the nearest five calendar years. These contracts are currently listed on CME ClearPort and the NYMEX trading floor.
