Pursuant to Section 5c(c)(1) of the Commodity Exchange Act, as amended ("Act"), and section §40.6(d)(2)(iv) of the regulations promulgated by the Commodity Futures Trading Commission (the "Commission") under the Act (the "Regulations"), and by the authority granted in Nadex Rule 12, North American Derivatives Exchange, Inc. ("Nadex", the "Exchange") hereby provides notice that it has added additional strike levels in its Daily Wall St 30, US Tech 100, Germany 30, US 500, and US SmallCap 2000 Binary contracts for trade date October 23, 2012. Nadex returned to its regular listing schedule for these contracts on October 24, 2012.

New strikes created on trade date October 23, 2012 are set forth in Exhibit A.
