**Re: Rule Amendment. New York Mercantile Exchange, Inc.
Submission #08.122: Notification Regarding the Assignment of New
Numbers for Rules for Certain Electricity Contracts, and European-
Style Gasoil Option and Gasoil Average Price Option Contracts**

Dear Mr. Stawick:

The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") is notifying the Commodity Futures Trading Commission ("CFTC" or "Commission") that, it is assigning new chapter numbers for the following NYMEX contracts: ERCOT Broker Seller's Choice Index Peak (SNL Energy), ERCOT Broker Seller's Choice Index Calendar Day Peak (SNL Energy), ERCOT Broker Houston Index Peak (SNL Energy), ERCOT Broker Houston Index Calendar Day Peak (SNL Energy), ERCOT Broker North Index Peak (SNL Energy), ERCOT Broker North Index Calendar Day Peak (SNL Energy), ERCOT Broker South Index Peak (SNL Energy), ERCOT Broker South Index Calendar Day Peak (SNL Energy), European-Style Gasoil Option Contract and Gasoil Average Price Option contracts. These new chapter rule numbers are necessary as a result of an inadvertent assignment of the original chapter rule numbers for certain Electricity contracts, and European-Style Gasoil Option and Gasoil Average Price Option contracts (listed below) to other contracts.

The following table lists the name of the Contracts, their original Rule numbers and their assigned new Rule numbers:
