## **Notification of Changes to Cover Sheet to Supplement S-1 of Form FBOT**

### **1 Introduction**

- 1.1 On 18 August 2012, Singapore Exchange Derivatives Clearing Limited ("**SGX-DC**"), in its capacity as the clearing organisation of Singapore Exchange Derivatives Trading Limited ("**SGX-DT**"), submitted a cover sheet to Supplement S-1 of SGX-DT's Form FBOT (the "**Cover Sheet**") to the Commodity Futures Trading Commission ("**Commission**").
- 1.2 The Cover Sheet was part of SGX-DT's application to be registered as a foreign board of trade with the Commission. An order of registration was issued by the Commission in favour of SGX-DT on 22 January 2015 on the basis of this application.
- 1.3 SGX-DC hereby notifies the Commission of certain amendments to the Cover Sheet, as a result of changes to its registered address. The amendments are set out in paragraph 2 below.
