BUSINESS ORGANIZATION

Describe organizational history, including date and, if applicable, location of filing of original organizational documentation, and describe all substantial amendment or changes thereto.

Since Eurex Deutschland (or "Eurex") is a public law institution with limited legal capacity, it is operated by Eurex Frankfurt AG ("EFAG"), which is a stock corporation ("Aktiengesellschaft") incorporated under German law. Eurex is owned by Deutsche Börse AG. Only Eurex itself is empowered with and entitled to all responsibilities and obligations

pursuant to the Exchange Act and the rules and regulations thereunder. EFAG does not have any legal relationships with Members or issuers under the German Stock Exchange Act. EFAG's responsibility is limited to exchange operations while all responsibility under the Exchange Act rests with Eurex. This division of responsibility between the exchange and its operating company is one of the core principles of the German Stock Exchange Act. The rationale behind this division is to combine the advantages of private enterprises with the delegation of legislative authority and comprehensive enforcement powers to a self-regulatory organization ("SRO").

Eurex is headquartered in Frankfurt am Main, Germany, and was formed as a result of the merger between Deutsche Terminbörse (DTB, a German derivatives exchange) and SOFFEX (Swiss Options and Financial Futures) on September 28, 1998.


