

**Demonstration that the contracts are not prohibited from being traded by US persons, i.e., the contracts are not prohibited security futures or single stock contracts, or narrow-based index contracts.**

Eurex does not offer or sell security futures, single stock contracts or narrow-based index contracts to persons located in the US.

All equity index-based Eurex products that have been made available for trading by US customers have been the subject of CFTC actions, either through no-action letters or certification. Eurex has demonstrated and relies upon the Commission's confirmation that these index products meet the criteria of Section 2(a) (1) (C) (ii) of the Commodity Exchange Act ("CEA").

To verify that an index is not narrow-based, the Commission confirms that the index satisfies the following criteria:

1. The index may not be comprised of fewer than 10 securities or components;
2. Any single security or component may not comprise more than 30% of the total index weight;
3. The first five largest securities or components may not comprise more than 60% of the total index weight; and
4. The lowest-weighted securities that together account for 25% of the total weight of the index may not have an aggregate dollar value of average daily trading volume of less than US \$30 million (or US \$50 million if the index includes fewer than 15 securities).

Access to products that Eurex makes available to trade may be customized by the trading platform. For market participants located in the US, trading in equity index based products is restricted to the following products are subject to the following respective CFTC actions:
